Dear County Supervisors,

I am writing to express that I am vehemently opposed to the idea of redistricting. I am especially concerned with the proposal of including North Coastal communities, namely Cambria where I live, my family has a business and we have owned a home for 25 years, with inland communities like Paso Robles. While the towns are similar in geographical latitude, there are far too many critical ways in which they differ and should remain as separate districts.

For example, "In Cambria, being unincorporated, we are significantly impacted by county Board of Supervisors' decisions, such as land use, road paving priorities, garbage rates and vacation rental growth. It is essential that this coastal corridor 'community of interest' remain in its current District 2 designation and not be redistricted to communities without shared commonalities. Realignment into any urban-based inland district would, in effect, suppress the voice and needs of the coastal unincorporated communities, while damaging an historically defined community of interest. Plan C specifically presents serious dilution of coastal interests and creates a lack of compactness, ignoring two of the five criteria in community-of-interest guidelines."

In my own personal experience there are strong differences in attitudes on many different levels, including political, between the two locations, including the propensity to follow the recent Covid 19 mandates. Each time I venture inland I am shocked by the amount of blatant non-compliance and cavalier attitudes about putting other's lives at risk.

I believe it would be an enormous mistake to combine the two areas and doing so would result in massive problems, of discord, dissatisfaction and strife during a time in history when we are all already experiencing so many personal and societal problems and pressures.

If indeed redistricting is to be implemented, I implore you most desperately to not combine the interior and coastal districts.
