3. Hospital Codes - Emma Lauriston (Sierra Vista Regional Medical Center)

Joint Commission would like to see a community approach to standardizing hospital emergency codes. Hospitals in SLO County follow standardized health care emergency codes for determined by Hospital Association of Southern California (HASC): http://www.hasc.org/hospital-emergency-codes

Discrepancies include:

- Code Crimson for massive hemorrhage vs Code Noelle used for maternal hemorrhage.
- Code White for Pediatric Arrest vs Neonatal Arrest
- Code Apgar for Neonatal Arrest

4. Emergency Operations Manual Updates – Elizabeth Merson (PHEP)

CDPH and State EMSA released new and revised chapter of the 2011 version of the California Public Health and Medical Emergency Operations Manual (EOM). Providers are encouraged to read the EOM and the function specific chapters. The full manual has not been revised to include the revised and new chapters, so those components need to be viewed separately.
