### Report ALL Results from SARS-CoV-2 Point-of-Care Tests

The County of San Luis Obispo Public Health Department reminds providers that, per Title 17 Section 2505 of the California Code of Regulations, any entity performing point-of-care (POC) testing for SARS-CoV-2 must report ALL test results. This includes both POC antigen testing and POC molecular testing. Examples include Abbott ID NOW®, Cepheid Xpert Xpress®, Quidel Sofia®, BD Veritor®, LumiraDx®, and Abbott BinaxNOW®.

**Positive results:** All positive results from POC testing for SLO County residents should be faxed immediately to the County Public Health Department at **805-781-5543**. Positive results must also be reported to CalREDIE via electronic laboratory reporting or as described in the Manual Laboratory Reporting Module if electronic laboratory reporting is not possible.

**Negative results:** Negative results must be reported to CalREDIE via electronic laboratory reporting or as described in the Manual Laboratory Reporting Module if electronic laboratory reporting is not possible. There is no need to fax negative results to the County of San Luis Obispo Public Health Department.
