Thanks for the update. Here are our responses...

We applied for USBR Title XVI funding on March 15 and Prop 1 GWGP funding July 15. We have not received a response for either program but will let you know when we do

- 2) Since applying, has there been any updates to the project permitting?
  - a. For example, project secured CUP or encroachment permit.

We have engaged with permitting agencies but have not secured any additional permits

- 3) Is your project subject to NEPA? Yes or no.
  - a. If yes, is NEPA complete?

Since funding is being pursued through USBR's Title XVI WIIN Act Program and the SWRCB's CWSRF, a CEQA-Plus document was prepared to help facilitate NEPA compliance. The Project initiated NEPA compliance efforts with USBR in January 2022. We are working with USBR representatives to meet NEPA documentation requirements.

- 4) What is the status of the design of the project?
  - a. What % plans are complete?

30% currently being reviewed by project proponents

5) Is there any change to the status of legal access / easements for the project, if applicable? We have engaged with public and private property owners but have not secured easements and legal access yet

## Status & Schedule Update:

- The Working Group is preparing for their upcoming meeting to recommend a suite of projects to move ahead in the application process.
- This meeting is scheduled for Thursday, August 24<sup>th</sup> at 10am. We will be meeting in the conference room of the SLO City/County Library.
