To vote on a measure, darken the OVAL to the left of the word "Yes" or the word "No". All distinguishing marks or erasures are forbidden and make the ballot void. Prohibits rent control and similar measures. Eliminates deference to government in property rights cases. Changes condemnation rules. Fiscal Impact: Increased costs to many governments due to the measure's restrictions.
