President/Vice President	4 years	January 20, 2017	Barack Obama/Joe Biden (Democratic)	At least 35 years of age; natural-born citizen of the United States; U.S. resident for at least 14 years.

The office of President and Vice-President remain a Partisan/Party Nominated office under the California Constitution as amended by Proposition 14 and SB6 in 2010. Candidates for the party nominated offices must meet the party qualifications set forth in Elections Code §§6041, 6340, 6520, 6720. Only voters who are registered with the political party for which the candidate is seeking the nomination shall be allowed to vote for the office, unless the voter has declined to state a party preference and that political party notifies the Secretary of State that any voter who has declined to state a party preference shall be allowed to vote in that party's primary election.
