The MHSA Mission

The funding is provided to each county to "create a state-of-the-art, culturally competent system that promotes recovery/wellness for adults and older adults with severe mental illness and resiliency for children with serious emotional disorders and their families."



The MHSA Vision

The MHSA pledges to look beyond "business as usual" to help build a system where access will be easier, services are more effective, out-of-home and institutional care are reduced and stigma toward those with severe mental illness or serious emotional disturbance no longer exists.



MENTAL HEALTH SERVICES ACT FISCAL YEAR 2018/19 ANNUAL UPDATE AND THREE YEAR PLAN



Homeless Outreach Team (HOT)

- In 2012-2013, a FSP focusing on homeless individuals was launched. Modeled after the AB 2034 Homeless Outreach Program which ended in 2007, the FSP team works to identify chronically homeless, severely mentally ill individuals who are unlikely to seek or enroll in mental health services on their own.
- In 2016-2017, 221 clients received outreach services.
 - 74 of these clients received mental health screening services
 - 52 of these clients received primary health screenings
- The 41 adult individuals who were enrolled in HOT FSP services in 2016-2017 yielded the following results:
 - 75% reduction in homelessness
 - 99% reduction in emergency room visits
 - 76% reduction in psychiatric hospitalization days
 - 95% reduction in jail days

2017-2018 Services Provided by PEI Middle School Family Advocates


- PEI Family Advocates connect Middle School youth and their families to mental health resources and community services.
- 5 bilingual Family Advocates worked with 229 at-risk families and youth from 6 PEI Middle Schools.
- 46% of these families needed intensive case management and follow-up services.
- Link Family Advocates educate families about their Middle School students social and emotional developmental needs and conduct outreach at 20 school and public events, reaching over 1,800 people.






Program Impact on Middle School Students

79% of students showed improvement in attendance, grades, and behavior in school during the 17/18 academic school year.

- North County SAFE Coordinator facilitated <u>18 SAFE meetings</u> for Atascadero Middle School and Flamson Middle School families



3 Target Locations: San Miguel, Cambria, & Nipomo <u>San Miguel will start Jan. 31, 2019</u>








Results from SAP Retrospective Survey

• Overall, the number of times students reported getting into fights or threatened someone declined by 46.8% after participating in the PEI Counseling program.

FNL Results from Youth Development Surveys


Learning and School Bonding

Innovation (INN)


3-by-3: Developmental Screening Partnership between Parents and Pediatric Practices

 Tests three methods to administer ASQ:SE for children 0-3 that includes a health educator, parent selfadministration, and child-care provider to understand which produces better results in early diagnoses and intervention.

SLO ACCEPTance: Affirming Cultural Competence Education & Provider Training

 Tests a pilot/never before used curriculum for mental health therapists/clinicians to address culturally and linguistically competent mental health services for the LGBTQ+ community.







- FY 2018/19 MHSA Revenue projected to decrease by about 7% due to the following:
 - ➤ No Place Like Home \$140M
 - ➤ Annual Adjustment

County of San Luis Obispo

- ➤Info Notice 18-038 MHSA Allocation & Methodology
- FY 2018/19 Allocation = 0.671845% (decrease of 0.002194% or \$40K)

Reversion

- ➤ AB 114 Spending Plan approved by County Board of Supervisors August 7, 2018
- ➤ AB 114 funds for INN & WET must be spent by June 30, 2020
- ➤Info Notice 18-033 guidance on future reversion
 - o CSS & PEI 3 years to spend from date of receiving the funds
 - o INN 3 years to spend from date of MHSOAC approval of project
 - Interest to be allocated to components and spent similar to other funding (76% CSS, 19% PEI, and 5% INN)



 FY 2018/19 Adopted Budget is \$18.6M (MHSA \$13.9M/Other Revenue \$4.7M)

➤ CSS: \$14.2M

➤ PEI: \$2.7M

➤INN: \$1.0M

➤WET: \$159K

➤ CFTN (Electronic Health Record Support): \$537K

Prudent Reserve (PR) Balances:

>CSS: \$5,768,556

➤ PEI: \$67,608

➤SB 192 – 33% max of CSS 5 year avg (\$2.8M)

o FY 2018/19 propose transferring back to CSS & PEI operating pending guidance

Fund Balance 07/01/2018 (excluding PR) = \$11,180,446



CSS Update:

- ➤ Full Service Partnership Majority of CSS Funding (51%)
 - o FY 18/19 current budget at about 43%
- **>**Grants:
 - ➤ MHSOAC SB 82 Children's Triage Grant
 - > State General Fund Allocation Homeless Mentally III Outreach & Treatment

PEI Update:

➤ No projected additional funding available at this time
