The MAC Stakeholder Group asserts that they have fully understood and made a decision regarding the changes for the following program/service:

Current Program/Service CalMHSA PEI Services	New Changes/Updates to Program/Services Increase contribution from 3% up to 5% of total PEI funding over each of the next 3 years.
Current Total Amount: \$98,035.20	New Total Amount: FY 22-23: \$157,288 FY 23-24: 5% of total PEI funding FY 24-25: 5% of total PEI funding
<p>Justification:</p> <ul style="list-style-type: none"> • Access to services require a 4% of total PEI funds contribution annually. SLO County has not increased the funding amount in recent years as PEI funding has increased, resulting in SLO County being below the required level of contribution. • Participation with the CalMHSA PEI program assists the state organization’s efforts with dissemination and direction of statewide PEI project campaigns, programs, resources, and materials; provides subject matter in suicide prevention and stigma and discrimination reduction (SDR) to support local PEI efforts; and develops local and statewide capacity building support and new outreach materials for counties, and community stakeholders; • The annual contribution provides SLO County access to a variety of supports and services including: <ul style="list-style-type: none"> ○ Implementation and Suicide Prevention and Postvention Technical Assistance with the SLO County’s Public Information team; ○ Directing Change outreach, general running of the Directing Change program including screening, judging, sourcing for the Awards Ceremony, mini-grants, the Hope and Justice category, social media creation, etc; ○ Take Action 4 Mental Health Campaign: Toolkits (including Holiday Stress toolkit, student athlete suicide prevention toolkit, May is Mental Health Matters Month, Suicide Prevention Week in September, and more), resource and material development, bulk price toolkits and resources (in addition to a portion of contributing members getting toolkits for select subjects included in their contribution), influencers, social media management, etc; ○ RAND consultation and evaluation of the PEI Programs. <p>Outcomes:</p> <ul style="list-style-type: none"> • The increase in contribution to 5% will unblock access to several special projects including: <ul style="list-style-type: none"> • Suicide Postvention Media Training; • Customizable county specific supports, resources, specialized projects; • Added access to promotional material, webinars, trainings. 	

On Wednesday, January 25, 2023: **Increase contribution to 5% of PEI for CalMHSA PEI services.**
