

# Pismo Capital Preventive Maintenance Project DISTRIC





#### **PURPOSE**

The purpose of this project is to improve ride quality of the existing pavement in San Luis Obispo County on Route 1 from Garcia Way to the South 1/101 Separation.

# **MAJOR FEATURES**

- The project will overlay the roadway with 0.2" of rubberized hot mix asphalt.
- Rumble strips will be added to the highway centerline where appropriate.
- Locations with curb and gutter or distressed pavement will be cold planed 0.2' prior to paving.
- Severely distressed pavement exhibiting a failed structural section will be removed and replaced.
- 31 curb ramps at intersections will be replaced or modified to comply with accessibility standards.
- Delineation, roadside signs, and guard railing will also be replaced. Electrical upgrades including signal and safety lighting, loop detector replacements, and census loops were also identified to be completed with this project
- Complete streets elements are added to this Capital Preventative Maintenance Project (CAPM) by widening the shoulders to 8 ft. from the Oceano Overhead to the Pismo Creek Bridge and striping for buffered bike lanes (a total of 8 ft width). See mapping at top of fact sheet for limits of buffered bike lanes.) Access will be maintained at all times with no bike detours required. Retaining walls will be constructed to support the sidewalk.
- In Oceano, outside of the downtown core to the south, a crosswalk will be added at Route 1 and 21st Street.
- A second at-grade 150-foot-long by 6-foot-tall retaining wall will be constructed along the southbound shoulder at the intersection of the U.S. 101 southbound off-ramp and Price Street (postmile 16.52) to fill a sidewalk gap.

\$13 million – State Highway Operation and Protection Program (SHOPP) funding

**Begin Construction: Fall 2022** 

End Construction: Fall/Winter 2023.



I did a Corbett Canyon tack sweep today. i picked up 190 tacks! Here is the haul:

The locations were

35.197059 -120.599306 Old

35.193183 -120.588098 Old

35.174557 -120.561762 Old

35.181414 -120.573394 Fresh

35.180487 -120.572219 Fresh

35.177400 -120.564109 Fresh

where "Old" means the tacks were well flattened and/or off the road, so were probably old (and may have been reported before) and "Fresh" means probably from today or yesterday. I've only listed places where I picked up a dozen or more.

I also found two patches on 8/13 at

When I arrived at the first patch another cyclist had just about finished clearing them. He said he would post the information, but I haven't seen it on this forum, so I'm mentioning it for the record.
