- Individual Projects Issued As Job Orders Under the Base Contract
- A Fundamentally Different Construction
  Procurement Relationship
- Performance-Based Contract



## MICRO JOC - 24 Overview

- Partnership between County (Owner) & Contractor
- Future Contract Work is Tied to Contractor Performance
- No Obligation To Award Specific Projects
- County can still Use All Other Methods For Accomplishing Projects
- Purchase Order / Informal or Formal Bidding
- County intends to issue one (1) contract with this advertisement

- Add on Overhead and Profit
- Calculate the Adjustment Factor
