Presentation:

Michael Patrick - Central Coast Veterans Helping Veterans, SLO Veterans Services Collaborative

- Michael Patrick joined the Marine Corps in 1969 and served 3 years
- Became a mentor in 2014 of the Veterans Treatment Court in San Luis Obispo
 - Veterans Treatment Court in San Luis Obispo was founded in 2013
 - Veterans Treatment Court deals with veterans with special circumstances go require more therapy rather than punishment
 - Purpose is to rehabilitate and give therapy to the veterans. Upon successful completion of program records are expunged unless they reoffend
 - > Developed a military diversion program for first offenders. Upon completion of this program charges as dismissed
 - Mentors follow along with veterans through their 2 year journey

- Veterans are subject to probation, have individual and group therapy sessions, and have to meet all requirements that judge imposes
- ➤ In 2015 the mentors incorporated to a non-profit to receive donations to share with veterans and families for veterans
- Program became aware of needs outside the program and in 2016 it received a grant to start providing interim in home care for immobile housebound veterans
- ➤ In 2019 it provided over 1,000 hrs. of in home care to about 17 to 18 veterans within the county
- ➤ Assembled 4 wheelchair ramps for veterans
- Collaborate with 2 Mexicans Junk Removal
- Assist with deep cleaning to keep veterans from being evicted

Ron Torres - Seniors Helping Seniors, Credentialed Veteran Home Health Service Provider

- Retired HR Director most recently at CAPSLO
- Seniors Helping Seniors provides non medial to medical care
- Seniors help seniors
- Seniors Helping Seniors is on the Veteran Health Administration (VHA) side, that how they are credentialed to be a provider
- If a veteran is the VHA system there is no income requirements no qualifications
- Biggest challenge has been veterans are not very trusting
- Started in less than a year old but have grown rapidly

Ryan Barney and Kendra Scott - Veterans Services Representative

- Claims
 - Organization files claims for disability compensations
 - > VA pension
 - > Survivor's spouse pension
 - Encourage veterans to file claims
- Compensation
 - Disability compensation
- Education
- Burial
- Health Benefits

George Moran - Veterans Center Veterans Affair Representative

- Services and Support
- Offers one on one counseling or group counseling
- Offers mindfulness groups, wellness groups, yoga groups, frizbee/golf groups
- Funeral services

Benjamin Albrecht, HUD/VASH – Veterans Affairs Supportive Housing Homeless Veterans (VASH)

- Houses homeless veterans
- One of the last counties that provides housing vouchers, this attracts more homeless to come to the County of San Luis Obispo
- Percentage wise the county has housed more Veterans than other counties
- Services for Homeless Veterans
- Housing almost a person a week and list gets bigger and bigger
- Of the Veterans that are enrolled in VASH at least one third are seniors
- Some of the highest needs for these seniors are in home cleaning, help with early on set dementia Alzheimer's. Level of care and needs have increased.

Brandy Graham - CAPSLO Supportive Services for Veteran Families (SSVF) Program Manager

- Grant funded through the VA in order to house veterans
- Eligibility criteria is a bit more flexible and address immediate needs
- Homelessness prevention
- Rapid rehousing program
- "Shallow "subsidy helps Veterans pays up 50% of rent for up to two years and recertify if they still meet income limits for an additional two years. Criteria is between 50-80% area income brackets.
- It is a requirement to do outreach
- Contract with San Luis Obispo County Legal Foundation to assist veterans
- Employment services, referrals, etc...
