Retired police chiefs asks county to resist 'radical' redistricting

Over the four decades we have spent in law enforcement, we have seen our country convulsed time and again by hyperpartisanship, proteststurned-riots and other political mayhem – yet America always regained its footing.

We both have been lifelong conservative Republicans, and believed in the values of collaboration, compromise and the rule of law. But too many Americans have rejected those values and replaced them with a win-at-all-costs mentality.

Now, almost a year after the Jan. 6 insurrection, we fear for the survival of our democracy.

We hoped America would regain its balance, but the raging has only grown worse, fueled in large part by too many elected bodies taking actions that will impede our ability to have free and fair elections.

Even here in our own county, aggressive confrontations and threats of violence are on the rise.

Look no further than the disruptions and harassment of local school boards, and abuse of minority groups. Our county elections official, Tommy Gong, was hounded by extremist and racist accusations.

A violent event like the Jan. 6 insurrection could happen anywhere, including here. We are concerned for everyone's safety, but particularly the safety of law enforcement personnel who will inevitably be called to quell confrontations.

How do we stem the rage?

Every citizen must become more vigilant.

Citizens must actively engage in the practice of democracy – not merely voting, but also attending government meetings and making your voices heard in a respectful, civil way.

Staying on the sidelines simply surrenders the field to the extremists.

Where to start?
Start with the SLO
County Board of Supervisors, who have an immediate opportunity to help
quell the rage – or make it
worse.

Every 10 years, with respect to the latest census, the supervisors review how the county's five supervisor districts are drawn. The board majority has promised an open and transparent process, but we are skeptical because:

Based on the minor changes in population, there is no legal requirement to change

any district boundaries.

The supervisors chose to ignore best practice and did not appoint a nonpartisan citizens' panel to advise on drawing boundaries.

• Even though current boundaries are fully compliant with election law, a majority appears to favor a radical redrawing of district lines that would lock in partisan advantages for the next 10 years.

The board has compressed a complicated process, jamming the three most critical public hearings into a five-week span, leaving little time for analysis.

At a critical point later this month, the board is allowing only three days for expert review of the maps.

If the majority opts for radically new boundaries simply to secure a partisan advantage for themselves, they will be fueling the rage.

Though we are concerned about the current process, we also know this board can be persuaded to do the right thing when confronted by concerned citizens.

Recently, for example, after a majority of the board indicated it was open to selecting an unqualified and openly partisan person to oversee local elections, hundreds of citizens spoke up in protest. One supervisor reconsidered, and the board ended up selecting a well-qualified elections official.

Supervisors,

I am rather confused by the state of the redistricting discussion and felt compelled to write you all despite the lateness in the process.

I fail to see how either the Patten Map or the SLO Chamber Map as they are known represents an appropriate outcome for any of the five districts.

As an Atascadero resident I am obviously concerned about the impact on our city. The Chamber map splits Atascadero for no discernable reason and the Patten map puts Atascadero into District Two. While this might make Atascadero the dominant presence in District Two, Atascadero is a North County community with no business being in a district with coastal communities with whom it has little in common and vice versa.

Beyond this admittedly parochial interest, I fail to see the desirability of the Patten map's radical departure from the common sense redistricting patterns of the past four decades.

The broad population change patterns of the county remain consistent. The North County and South County continue to grow more rapidly than the coast and center, with the coast actually losing population this decade. In the past, this has resulted in District 1 pulling northward. When I came to Atascadero, the 1/5 dividing line was in the middle of Atascadero and migrated north with each redistricting. As a result of its own growth and district 1 pulling north, District 5 has also progressively pulled northward gradually exiting the City of SLO. District 4, with rapid growth has pulled south. With slow or no growth, District 2 has gradually needed to take in more of SLO to reach population balance and District 3 has been left in the middle.

This pattern has made sense and caused the least disruption to voters and their representation. One of the failings of both the finalist maps is they still leave the population numbers somewhat imbalanced with too many residents in Districts 1 and 4, and too few in 2 and 3. This is disappointing in that growth patterns will exacerbate these unnecessary differences.

There are always some political implications from redistricting and this may be unavoidable, but the Patten map is so radical it can hardly be interpreted to have other than political motives. The same was true of one of the early maps pointedly proposing no changes to District 4 for obvious political reasons. It seems that the Patten map deliberately makes each district more pronounced in it political leanings based on registration.

Following the previous redistricting pattern would make the most sense, and incidentally, have a similar, if less pronounced political impact. District 5 would pull farther out of SLO, especially if you better balance the population numbers which would pull 1 and 5 farther north. This would further enhance District 5's identity as a north county district as opposed to

the completely unnecessary reorientation of the Patten map.

District 4 should pull south, possibly leaving behind Oceano or other appropriate amount of population. This might have similar political implications but that would be an incidental byproduct of growth patterns, as opposed to a political rewrite represented by the Patten map.

The Patten map's radical rewrite may subject the county to unnecessary lawsuits further clouding the redistricting picture when an easy alternative was and still is possible.

Dear Chair Compton and SLO County Board of Supervisors.

The Atascadero Chamber of Commerce represents nearly 550 members that employ approximately 5,000 residents in northern San Luis Obispo County. Representatives from our Board of Directors met and brought their experiences as business leaders who live in different districts and who work in different industries to the table to evaluate the proposed maps. After careful review and evaluation, we are pleased to submit support for a slightly modified version of the proposed SLO County 2030 map. The Board representatives found that the SLO County 2030 map meets the legal requirements and is the most thoughtful when considering the challenges and opportunities faced by each community within our County.

As currently proposed, the Map divides the city of Atascadero into District 2 and District 5. We believe to meet the spirit of redistricting, that the city of Atascadero should remain whole rather than divided. The portion of District 2 that includes Atascadero encompasses approximately 4,000 residents who live on larger ranchette style parcels. Because this area of Atascadero has little in common with the majority of District 2 and future planning considerations, Atascadero should remain fully intact within District 5.

To accomplish our suggested modifications and remain within the scope and population guidelines determined in this process, we propose the following:

Remove a portion of District 5 near the Cal Poly campus

 Allot census tracts located west of Santa Rosa Street in San Luis Obispo and move to District 2

These *minor changes* would unify the City of Atascadero and would allow the District 2 supervisor to focus on coastal community issues and challenges. With these modifications, we can comfortably support the SLO County 2030 Map as presented by the SLO Chamber of Commerce.

Finally, we would like to *voice our opposition of the Patton Map*. While this map keeps the city of Atascadero whole, it places the entire community in District 2 which is inconsistent with the "communities of interest" criteria as stated above. It is our opinion that this mutes the will of the voters who elected representation for the current District 5 in 2020.
