Good morning:

In order to support the goals of strong public engagement and transparency in the Redistricting process, I am requesting that the County host regional workshops where community members can work with County staff and the Redistricting Partners to create various district maps. Ideally these workshops will be held in person in venues that allow social distancing (such as the South County regional center in Arroyo Grande and the Board Chambers in San Luis Obispo). These workshops need to be held before final maps are created and submitted to the Board for consideration.

Workshops of this nature were held in Atascadero, San Luis Obispo and Arroyo Grande in 2011 when the 2010/11 Redistricting Process was underway. Robust marketing of these workshops will be needed to encourage attendance.

While the Redistricting mapping tool on the website is fairly easy to work with for tech savvy people, it is not entirely intuitive and may be difficult for some people to use in creating maps. These workshops will give people an opportunity to see what happens with population numbers/district as the lines are moved - viewing different scenarios.

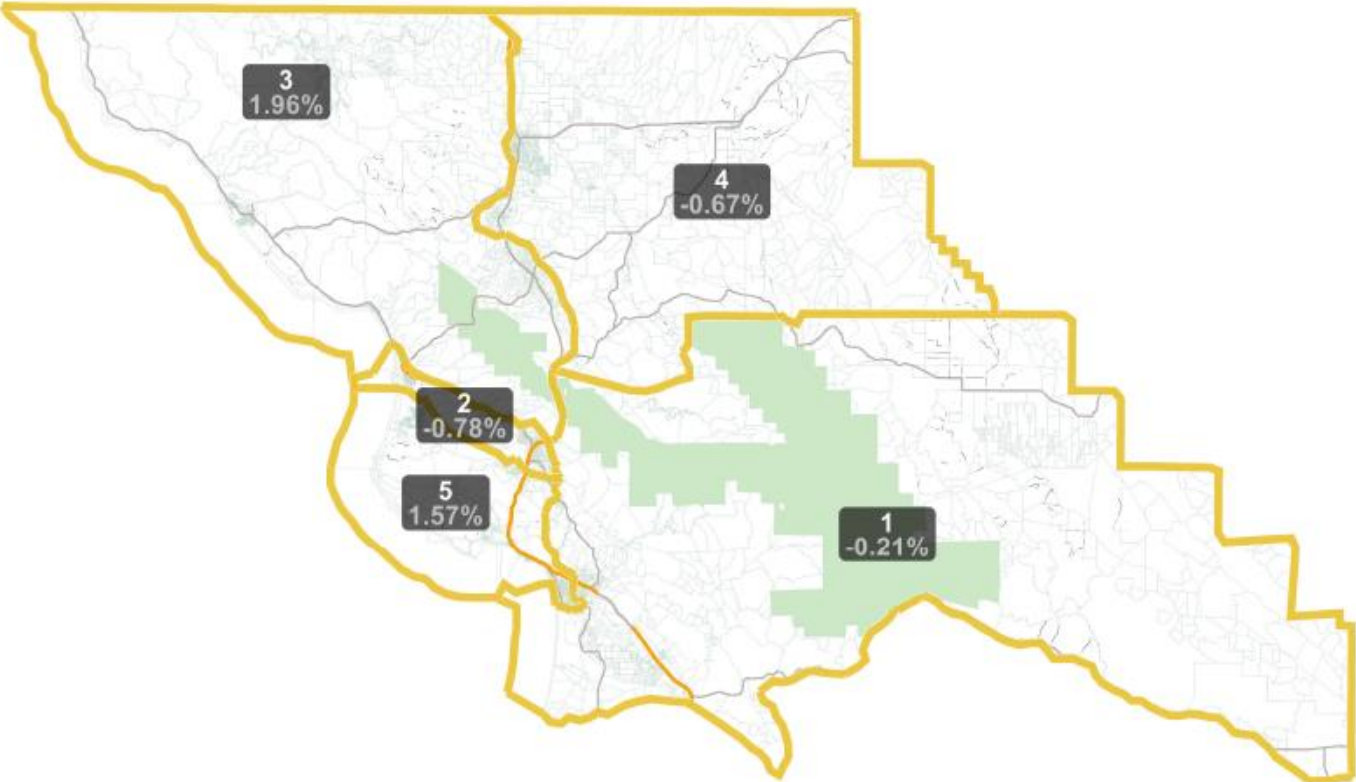
