a) I urge the Board to keep Oceano within District 4 as it is now. I have heard that Lynn Compton is trying to move Oceano out of the 4th District and move more of Edna Valley into the 4th district in order to increase votes for her reelection to the BOS. This is not appropriate for the following reasons.

First, gerrymandering is defined as manipulating the boundaries an electoral constituency so as to favor one party or class. This is not fair. The BOS website states that "...districts shall not be drawn for purposes of favoring or discriminating against an incumbent, political candidate, or political party."

Second, The BOS website states that "The geographic integrity of city, local neighborhood, or community of interest shall be respected in a manner that minimizes its division." and that "districts shall be drawn to encourage geographic compactness." Oceano lies within the Coastal Zone and its community members identify with the dunes. Distinct from other communities nearby, Oceano is an unincorporated community, like Nipomo down the road. Nipomo air quality is affected by the dunes area to the south of Oceano. In fact, two advisory committees now exist to weigh community matters, both focused largely on dunes to the south.

b) The Board of Supervisors recently voted not to allow a citizen advisory council to work with the Board. The BOS exists to serve the citizens. Communication is important. An advisory council should exist to support the flow of citizen opinion.
