

We are writing to you to humbly request that a minor modification be made to the Richard Patten map, if it is chosen by your Board.

In its current form, the Patten Map cuts through the community of San Miguel, cutting off parts of our San Lawrence Terrace from the rest of the community. Because of this, we are requesting that all of the San Miguel CSD Boundaries are kept together in District 2. According to your modeling, this would represent a shift of exactly 100 residents from District 1 into District 2.

The existing CSD boundaries are the long-accepted boundaries of our community. By making this change it would keep our small community intact, respect our Latino community, and improve the max deviation from 4.85% to 4.67%.

If Census Blocks must be used, we have attached a map of the area showing our proposed changes, versus the Patten Map, and a map of the San Miguel CSD Boundaries.





Of the two district maps under consideration, Richard Patten's map is a radical departure that dramatically and negatively affects the representation Avila Valley would receive. It also cuts apart communities with shared interests.

For the Avila Valley, it significantly reduces access to and direct involvement and oversight by the supervisor responsible for our area. For our district it could result in having 20% less of our supervisor's time due to the number of councils included in the new district.

Our community is unique. Not because we are unincorporated but because of the composition, (e.g. numerous HOAs, large recreational areas and rural communities, commercial areas catering as much if not more to non-residents than locals, closest community to nuclear power plant (underway to be decommissioned), non-city water and sewer services, vast number of acres of oak woodlands and open space, an older population, large number of second homes, vacation rentals) and special conditions (e.g. high fire risk area, one-way in/out, limited parking, high seasonal and event traffic). Our area needs a model that allows the supervisor to devote the necessary time to address the constituents' concerns and needs and to understand the long, complex history of how we got to where we are.

For SLBE, Patten's redistricting has the potential of undoing much of the progress that has occurred.

I ask you to keep the map that exists today or adopt the map generated by the Chamber of Commerce.

This would expand our district including Avila Beach to additionally include Los Osos and Oceano, running from the southern end of Pismo Beach to the edge of Morro Bay State Park (including Diablo Canyon). It also includes the Laguna Lake and airport areas of south SLO making it the largest district with 57.5K people. SLO City would be reduced from three supervisors to two.

The result would be county district services spread out over a much wider area, meaning our supervisor would be responsible for a larger area of SLO City, plus two county airports, plus Oceano & Los Osos. County services and district supervisor attention to Avila Beach will be substantially diminished within this new district.
