\* **Period Covered:** The period covered by any statement begins on the day after the closing date of the last statement filed, or January 1, if no previous statement has been filed.

## **Additional Reports**

- Local Ordinance: Always check on whether additional local rules apply.
- Filing Deadlines: Deadlines are extended when they fall on a Saturday, Sunday, or an official state holiday. This extension does not apply to 24-hour independent expenditure reports (Form 496) and the deadline for the Form 497 that is due the weekend before the election. Such reports must be filed within 24 hours regardless of the day of the week. Statements filed after the deadline are subject to a \$10 per day late fine.
- Method of Delivery: All paper filings are filed by personal delivery or first class mail unless otherwise noted. A paper copy of a report may not be required if a local agency requires online filing pursuant to a local ordinance.

## **Fair Political Practices Commission**

- Form 501: All candidates must file Form 501 (Candidate Intention Statement) before soliciting/receiving contributions.
- Form 460: Candidates who have raised/spent \$2,000 or more file the Form 460. The Form 410 (Statement of Organization) must also be filed once \$2,000 or more has been raised/spent.
- Form 470: Candidates who do not have an open committee and do not raise or spend \$2,000 or more may file Form 470 on or before September 2, 2017. If later during the calendar year, a campaign committee must be opened, a Form 470 Supplement and a Form 410 must be filed.
- After the Election: Reporting requirements will depend on whether the candidate is successful and whether a campaign committee is open. See <u>Campaign</u> <u>Disclosure Manual 2</u> for additional information.
- Public Documents: All forms are public documents. Campaign manuals and instructional materials are available at <u>www.fppc.ca.gov</u>, click on the "Learn" link.
- Committees making independent expenditures to support or oppose candidates or ballot measures also file:
  - <u>462</u>: This verification form must be e-mailed to the FPPC within 10 days of making an independent expenditure of \$1,000 or more.
  - <u>496</u>: This form is due within 24 hours when made in the 90-day period before an election or on the date of the election. Refer to the candidate or ballot measure election filing schedule.
