- Frank Warren welcomed the stakeholder group at 4:00 pm. All participants introduced themselves and Frank presented the goals for meeting. Frank also reviewed the Stakeholder Process, format, and rules for the meeting (e.g. consensus voting, no rules of order, etc.)

 - Joe Madsen (TMHA) discussed the Assisted Outpatient Treatment (AOT) Full
 Service Partnership. He discussed basic strategy and team meeting schedule.
