CPACS Updates

Next week we will host another Just-in-Time training on Thursday, May 28th for medical professionals willing to work in the Red Zone conducting direct patient care. This training is specific to our facility and must be conducted if you want to be ready to be called on for if the CPACS receives patients.

In addition, we have opened appointments for N95 Fit Testing for next week which is also only for medical professionals able to serve in direct patient care roles. An N95 Mask is required for all medical volunteers serving at our Clinics in direct patient care.



COVID-19 Clinics

The County of San Luis Obispo has partnered with US Health Fairs to set up COVID-19 Testing Clinics. These clinics started on May 19th and are planned for various locations around the county. These clinics have been primarily staffed by MRC volunteers!

We are now allowing volunteers to self-schedule via an online sign up sent via email. Each clinic will have a unique link with all the details & shifts for all needed volunteer positions. Please keep an eye on your inbox for this sign-up as the positions fill quickly.

The next clinic that we will need volunteers for will be in Atascadero, and we will send out the sign-up for that by Wednesday next week!


