| 1. Agenda Item: Welcome/Introductions (Facilitator: Nestor Veloz-Passalacqua) | The meeting for the San Luis Obispo County Care Coordination Coalition was called to order at 12:05 p.m. by Nestor Veloz-Passalacqua, Whole Person Care Program Manager, Health Care Access Division, County of San Luis Obispo. Introductions: Everyone went around the room and introduced themselves and their organizations. Handouts: Nestor confirmed the delivery of the meeting minutes for the 1/15/21 meeting. | No |
| 2. Agenda Item: Review Minutes – January 2021 Meeting | Minutes were approved as written by Ron Yukelson and Mark Lamore. | No |
| 3. Agenda Item: SLO-HUB Grant Report | Nestor introduced Crystal Racicot to present the information. Additional slides will be shared with the coalition. Some highlights include: <ol style="list-style-type: none"> 24 participants enrolled, 18 have found housing, and recently two additional clients found housing through Section 8 Housing and ECHO Homekey services; Continued outreach to participants is essential but there has been a decline due to COVID19; So far 4 participants have tested positive for COVID19 with no serious symptoms and one client unfortunately passed away; The Railroad Parking Program is about to start in the upcoming weeks. There was little notice and word of mouth is still getting out. Additionally, some clients don't want services. Check-in for county residents begins at 6pm. For out of county residents, check-in is from 6:30pm-7pm. Participants must be in cars; RVs not allowed. They must present title, driver's license, car insurance, and if they have a pet, proof of vaccination. Work with the Holman Group and with Community Counseling Center for a medical doctor and therapist respectively is in the works; The new Medication Assisted Treatment Center is scheduled to open on the grounds at Prado July 31st. | Nestor will send the slides along with the meeting minutes. |
| 4. Agenda Item: Medi-Cal Rx | Terri Howell announced that the implementation of the Medi-Cal RX has been pushed back further. There has been a potential conflict of interest since Magellan Health purchased the company that logistically would implement the new program. | |

| 5. Agenda Item: ECHO Paso Robles Project Homekey Update | Wendy Lewis prepared a PowerPoint presentation. The PPT will be shared via e-mail to coalition members. | Nestor to e-mail PPT to coalition members. |
| 6. Agenda Item: Whole Person Care Pilot Project Update | <p>Nestor announced the following information:</p> <ol style="list-style-type: none"> 1. The Whole Person Care Pilot Project MOU has been submitted for review with County Counsel. 2. The Octavia MOU, which will help us test the applicability of Octavia with various agencies is under review with CAPSLO (40 Prado). Once feedback is received, a final draft will be developed and send for approval with County Counsel. 3. A set of logos have been sent to agencies to review, rank, and approve. 4. The final draft of the newsletter has been sent and will be released at the end of the month of March. 5. There is a final draft of the Metrics that will be submitted to the CCC Executive Group for review, and then to the overall members for additional feedback. | Nestor to follow up via e-mail with metrics and if MOUs are complete, these will also be sent for additional review. |
| 7. Agenda Item: Roundtable County Vaccine Update | <p>Nicole with CenCal stated that transportation is available for CenCal clients who are scheduled to get a COVID19 vaccines. They need to call 48 hours in advance. They can access the following website: https://www.cencalhealth.org/~media/files/pdfs/covid/faststartguide20210217.pdf?la=en</p> <p>Michelle with the Public Health Department, mentioned that currently, the Health Care Access Division has a Nurse Navigator position that is available.</p> <p>Ron with Wilshire stated that with the addition of the Johnson & Johnson vaccine, accessibility should increase.</p> <p>Grace with 40 Prado stated that CHC had put together a pop-up vaccination clinic and about a total of 85 clients at 40 Prado had received the COVID19 vaccine.</p> <p>Dr. Mulkerin with Sheriff's Dept. stated that they had been awarded about \$430k specifically related to re-entry services and to secure available beds for individuals leaving the jail and seeking shelter. Services will also include Medication Assisted Treatment (MAT) and associated costs. It is to be implemented on March 31st and it is meant to address re-entry services and recidivism.</p> <p>Anne with the Behavioral Health Department stated that there is a potential expansion to the Central Coast Hotline to private insurance as well as CenCal. In the County about 45% of clients are Medi-Cal beneficiaries, while 55% represent other. Now the Crisis Stabilization Unit (CSU) will be open until 9:00 pm.</p> <p><u>CARES Act Coordination Pilot</u> – Grace with 40 Prado stated that through funding from the CARES Act there is dedicated Dignity Health staff to support individuals experiencing homelessness through their Transitional Health Care Center as a</p> | |

The funding is available for 1 year for long-term care.</p> <p>SB 855 – Anne with SLOBHD stated that beginning January 1, SB 855 authored by Senator Weiner will require now private insurance to begin including service provision and all regulatory elements for any behavioral health disorder, specifically those focused on Drug & Alcohol services.</p> | |
