6. BAC Business & Discussion

B. ATP Grants

Recommendation: Direct BAC chairperson to submit letters of support for the Bob Jones Trail and Orchard Avenue Bike Lanes ATP grant applications

Discussion: On September 26, 2013, Governor Brown signed legislation creating the Active Transportation Program (ATP) in the Department of Transportation (Senate Bill 99, Chapter 359 and Assembly Bill 101, Chapter 354). The ATP consolidates existing federal and state transportation programs, including the Transportation Alternatives Program (TAP), Bicycle Transportation Account (BTA), and State Safe Routes to School (SR2S), into a single program with a focus to make California a national leader in active transportation. The Cycle 3 ATP applications are due 6/15/16. The County of San Luis Obispo will be applying for the same projects as in Cycle 2 including:

- Bob Jones Trail
- San Juan Creek Ped Bridge
- Orchard/Tefft Ped Improvements at Dana Elementary
- Oceano Elementary Paso Robles Street Sidewalk In Fill
- Orchard Ave Bike Lanes (Southland to Joshua)

Results: Construction of these projects enhances alternative transportation modes, provides for more traffic and bicycling safety, and creates a more livable community.

C. <u>Bikeway Class Modifications</u>


Recommendation-

Designate Class III Bike Route on:

 H Street between Encina Avenue and State Highway 58

Delete Class III Bike Route on:

 I Street between Encina Avenue and State Highway 58.



- (4) Class III Bikeway (Bike Route). Bike routes are shared facilities which serve either to:
 - (a) Provide continuity to other bicycle facilities (usually Class II bikeways); or
 - (b) Designate preferred routes through high demand corridors.

As with bike lanes, designation of bike routes should indicate to bicyclists that there are particular advantages to using these routes as compared with alternative routes. This means that responsible agencies have taken actions to assure that these routes are suitable as shared routes and will be maintained in a manner consistent with the needs of bicyclists. Normally, bike routes are shared with motor vehicles. The use of sidewalks as Class III bikeways is strongly discouraged.

Discussion:

 Current Bike Route on I Street between Encina Avenue and Highway 58 is not contiguous with the Bike Route on H Street east of 58. The intersection of Encina Avenue and I Street is all way stop controlled and bike routs can be signed accordingly.

Results: Reclassification of these bikeways will facilitate a complete bicycle network leading to a safe and livable community.

I. County Parks

Shaun Cooper provided updates on the Parks projects. Bob Jones Pathway working on updating NEPA document to match EIR changes. Then can proceed with ROW. Morro Bay to Cayucos wrapping up environmental studies, ~30% construction documents. Coastal Development Permit needs Chevron's consent of land owner.

III. County Public Works

Michelle Matson provided updates on Public Works projects. Bike lanes were successfully added to Division, Thompson and Hazel during the pavement overlay projects. See Michelle after meeting for 3ft to pass sign list and centerline rumble strip list.

IV. Caltrans

Statewide bicycle and pedestrian plan is under development. Skip asked when the Highway 1 rumble strip project will begin. Anyone can email Amy Donatello for information. The State is also doing a pilot program investigating a road user charge

6.Presentations

A. <u>SLOCOG Prioritizing Projects for the Regional Transportation Plan, Transportation Funding</u>
Stephanie Hicks and James Worthley from SLOCOG presented information on the proposed sales tax measure. The State revenues have decreased and STIP funding is set to end. State and Federal gas tax are not sustaining transportation projects. SLOCOG investigating being a self-help county and adopt a half cent sales tax. Requires 2/3 of voters to pass. Expenditure plan will detail project and will be developed after the polling. Expenditure plan is important to

gain voters support based on projects they care about.

BAC members and guests participated in an interactive poll/survey to gather information for sales tax measure.

B. Caltrans US 101 North Paso Rehab Project – Amy Donatello from Caltrans

Amy Donatelo from Caltrans came to discuss the rehab project. Flyer noted comment period ended on 2/9, comments will be accepted for a few more weeks. Project will widen the shoulders from 8 feet to 10 feet, pave the road and improve drainage. Starts at San Miguel crossing and ends 8 miles north at the Bradley Rad exit, Project duration is approximately 2 years done in segments and will be a lot of one way traffic control. Flyers sent to bicycle group to determine bicycle travel through project and potential detour, etc. Amy passed out comment cards.

Robert Davis noted no parallel route with bicycle facilities and mild terrain. Shuttles, temporary paving or gravel road, detour though Camp Roberts and other measures were mentioned. Skip noted duration is long. Lea noted likely no cell phone reception on northern part of potential detour.

7. BAC Business & Discussion

A. Minutes of 11/10/2015

Josh Oleiczak motioned to approve the minutes. Ken Price seconded. Motion approved.

B. <u>Bikeway Class Modifications</u>

Michelle summarized the proposed bike routes. There are no existing bike routes in the southwest area of Cambria. Staff has reviewed speeds, collisions, etc. Bike Routes are also proposed on K Street and San Luis Obispo Road in San Miguel based on comments from the San Miguel Advisory Committee.

Robert moved for staff recommendation. Skip seconded. Claudia does not support Bike Routes on Burton Drive or Ardath Drive due to elderly drivers. Robert, Josh, Lea and Skip noted bikes are using the road and is good to remind vehicle of bicycles. All in favor of motion.

C. Bike Plan

Michelle has been working on the draft bike plan; however, hard copies were not available for the meeting. Goals have been further revised and the new bikeway modifications will be added. Michelle can release public review draft or submit to committee for an additional review.

Red suggested committee comments be submitted along with public comment to stay on schedule. Skip would like an additional one-two week committee review prior to release to the public. Ed motioned to stay on current schedule and BAC comments to be submitted during public comment period. Bill Kennedy seconded. Motion passed. Dale reviewed schedule, hard copies will be provided to committee members. BAC members should go back to advisory councils. Calendar is in agenda package.

Josh brought in new BAC logos. Josh asked artists for logo to incorporate on cover which may also have required items from county. Submit comments to Josh by end of February. Will act on logo at May meeting.
