# Upcoming Federal Housing Grant Opportunities From Stimulus

---

- **American Rescue Plan Act**

- Enacted March 11, 2021
- Funds for
  - \$5 billion nationwide for HOME Program to create housing for persons experiencing homelessness or who are at risk of homelessness
    - Approximately \$3 million expected for SLO County; timeline not certain

# Upcoming Federal Opportunity via the State

---

- **Section 811**

- Project-based housing vouchers for persons with disabilities
- Passed through via California Dept. of Housing and Community Development (HCD)
- Recent announcement that surplus funds are available on an over-the-counter basis
  - No official application deadline, but a project's Rental Assistance Contract (RAC) with CalHFA must be executed no later than September 30, 2021.

# Upcoming State Opportunities for Housing

---

## Homeless Housing, Assistance and Prevention Program Round 1

- Local Requests for Proposal (RFP) to be released by County of SLO Department of Social Services in April 2021
  - Eligible activities include capital projects for permanent housing; operating subsidies and reserves; supportive services for permanent supportive housing; delivery of permanent housing and innovative solutions, including hotel/motel conversions
- Approximately \$3.1 million available for local applications
  - Approximately \$268K must be set aside for projects that assist homeless youth

# Upcoming State Opportunities for Housing (cont.)

---

## Project Homekey

- In the Governor's budget for FY21-22
- Provides funding for acquisition and conversion of motels and other properties into permanent housing
  - Example from prior round: Motel 6 acquisition by HASLO for permanent housing and emergency shelter

- Eligible activities may change before passage; unclear whether awards will be competitive or formula-based



# State Funding Opportunities for Housing (Continued)

---

## No Place Like Home

- Loans for development of permanent housing for persons who are homeless or at risk and are in need of mental health services
- Counties are eligible applicants but can apply with housing development sponsors
- Notice of Funding Availability (NOFA) anticipated October 2021
- Last Round of Competitive Funds
- Anticipated \$400-\$500 million

- Current status from prior rounds
  - NPLH Competitive Round 3: Pending announcement: 1 application submitted
  - NPLH Competitive Round 2: \$10.8 million awarded to local project, waiting on contract from state
  - NPLH Noncompetitive: Submitted application: pending agreement from HCD

# State Funding Opportunities for Housing (Continued)

---

## Veterans Housing and Homelessness Prevention Program

- Funding for acquisition, construction or conversion of properties for affordable housing or transitional housing
  - Requirements for set-asides for homeless veterans; income requirements

- Annual County Action Plan
