ADDENDUM TO WELL PERMIT APPLICATION - FEE WAIVER REPLACEMENT
WELL REQUIREMENTS & WELL OWNER SIGN - OFF

Pursuant to the San Luis Obispo County Board of Supervisors, as of August 27, 2013, replacement wells meeting the requirements listed below will be eligible for a well construction permit fee waiver from Environmental Health Services.

A well construction permit fee waiver only applies to domestic wells documented to have failed to provide adequate domestic water (dry well).

The following information shall be submitted to this office as documentation that the original domestic well has failed:

- 1. The well owner shall submit a letter of explanation documenting the failure of the current domestic well to provide adequate water. A letter from a licensed and bonded well drilling contractor documenting the failure of the domestic well is acceptable.
2. The well owner shall also provide the Well Completion Report (also known as the Well Driller's Log) for the failed well if it is available (requests for copies of the Well Completion Report shall be made to the CA Department of Water Resources, c/o Michael Van Raalte, Groundwater Section, 770 Fairmont Avenue, Suite 102, Glendale, CA 91203, 818 - 500 - 1645, waterdata@water.ca.gov).
3. Documentation can also include recent receipts for hauled water to the property. Such receipts shall clearly identify the water hauling company (with name, address & telephone number) and the property address.
4. The well owner shall verify the current domestic well was drawing groundwater from an area that has been certified as a Level of Severity III by the San Luis Obispo County Board of Supervisors through the Resource Management System.
5. The failed well shall be located accurately on a map and the property's Assessor's Parcel Number (APN), section/township/range, street address, and GPS coordinates provided.
6. The well owner shall contract with a licensed and bonded well drilling contractor who will then submit a Well Permit Application for a domestic replacement well on behalf of the well owner.
7. The replacement well owner shall sign this document acknowledging that they understand the well construction fee waiver only applies to the replacement of a private domestic water well that no longer produces an adequate amount of water to sustain the domestic needs of the household.
