	inspecting or testing the devices as required by law, to recover the costs of inspecting or
	testing weighing and measuring devices required of the county sealer pursuant to Section
	12210, and to recover the cost of carrying out Section 12211." The proposed fees are at
	or below the limits specified in statute. For FY 2021-22, the projected total costs of the
	device program is \$475,605.46, based on current workload and projected costs. The
	proposed FY 2021-22 device registration revenue is \$246,435.64, based on the total
	number and type of locations registered and the number and type of devices inspected.
	This represents a projected cost recovery of 51.82% for the device inspection and
	enforcement program.
