Call to Order

Meeting began at 10:38 am with a welcome from Denise Yi and introductions from all in attendance.

TOPIC DISCUSSION **AGENDA ITEMS** • Public Health has been meeting monthly with the Office of Emergency Services (OES), Fire and City PUBLIC SAFETY POWER SHUT OFF representatives to plan on how to help medically fragile and oxygen dependent individuals during a **PLANNING UPDATES Power Safety Power Shutoff event** DENISE YI Areas of Discussion Public Health and/or Medical Reserve Corp nurses may do well checks at shelter sites for those dependent on electrical devices If electrical device charging shelters open: • Triggers, notification and staffing are all still being discussed. • OES will open their phone assistance center to help take calls from 9-1-1 • Dr. Beebe asked if the whole county would be shut off or just portions Kelly VanBuren from OES stated it would likely be a large portion of the county since SLO county is at the end of the 3 transmission lines that run through the central valley (Coalinga) o Emma Lauriston from Sierra Vista Regional Medical Center said Sierra Vista and Twin Cities Community Hospital are meeting to create a response plan specifically for PSPS which must be submitted to Tenet. She stated that their big concerns are infectious disease and surgery, since both rely on chill and their HVAC systems are not on the backup generator; they will immediately active "Code Triage Internal" • Lizz Davis from Davita Home Training teach their patients on backup procedures that include 5 days of backup/manual supplies as well as telling them to sign up for the PGE Medical Baseline

 Dana Melgares -Arroyo Grande Community Hospital/Marian Home Care-Infection control is their biggest concern, along with staff preparedness • Anju Agarwal – Dignity Health Home Care-they are contacting their suppliers and asking for 2 oxygen tanks as backups for each patient; they will contact all their patients and see what durable medical equipment they need • Kerry Boyle – San Luis Fire – held a public information meeting at the library which was well attended. Most of the people attending had no clue about PSPS; during his regular inspections of grocery stores he has found that none of the stores are prepared for a PSPS and have no backup generators to keep refrigeration running. • MaryJean Sage – Health Commission: will follow up with information that was presented by Public Health at their last meeting • Erica Stewart (Cal Poly Health/Housing): have 48 generators which will be used for refrigeration and operation of their EOC (which for a PSPS will be at the Performing Arts Center; they will have daily town hall meetings to keep students and staff up to date on the event. They have a list of all students that rely on electricity for medical devices **AGENCY-PROGRAM REPORTS** Recruitment for the Public Health Program Manager position is still ongoing DENISE YI Standard Operating Procedures (SOP) and Plans PHEP REPORT • Receiving, Staging and Storage (RSS) SOP is out for signature o Isolation and Quarantine SOP is out for review o Communicable Disease Response Plan is being updated • First Responder Point of Distribution (FRPOD) • Annual flu shots • November 6, 2019 at 4 locations (flyer attached to these minutes) • County Health Officer (CHO) sent a letter to all healthcare workers that they must get a flu shot by Nov. 1, 2019 or else wear a mask when dealing with patients. First Responders have until Nov 7, 2017 to get a flu shot • Public Health Nurses will assist with flu shots at Cal Poly in 2 weeks and at the Health Commission's next meeting
