1. Meeting Introduction and Program Update - Denise Yi

- a. CDPH is not requiring participation in the Statewide Medical and Health Exercise until Spring 2024. PHEP is considering coordinating an exercise with local healthcare partners. Survey going out to gauge interest from HPP and HCPWG partners. Please complete by 8/31/22.

- c. PHEP and EMS will be participating in the Diablo Canyon Nuclear Power Plant Dress Rehearsal on Wednesday 8/10/22. FEMA evaluated exercise will take place on Wednesday 9/14/22.

2. Monkeypox Update

CA MPX Cases

- o 1,733 confirmed/probable cases.
- o 31 LHJs.
- o 36 hospitalizations.
- o No deaths.
- o 63% of cases reported by San Francisco and LA.
- o Newest LHJs reporting cases: Sutter and Santa Barbara
- o Quest Lab is conducting the majority of testing in CA

Local Situation

- No reported cases in San Luis Obispo County
- PH has small cache of Jynneos vaccine and TPOXX
 - MCM is only approved for laboratory staff handling Orthopox specimens, close contacts of a lab confirmed case and anyone who has recently attended a sex party with a lab confirmed case.
 - 9 doses have been administered in SLO County.
