Funding Available:

- DWR proposes 50% of general implementation funds and 35% of DAC implementation
- This amounts to ~\$3.1 million for our region, based on the MOA with Funding Area partners.

Grant Award Timing (mid to late 2019):

- Application submittal dates vary by Funding Area.
- Expected application due date is Sept. 2019.

Local Cost Share:

- 50% of total proposal cost being paid by for with non-State funds.
- Costs incurred after January 1st, 2015 can be used for local cost share
- Waived or partially reduced for projects/proposals that directly benefits DACs

Reimbursement Eligibility:

- The "funding award date" as the date reimbursements will start.
- For the Central Coast Funding Area, this roughly points to Nov. 2019.

Agreement Requirements:

- CEQA and Construction permits must be complete by the Agreement, est. March 2020.
 - o If not, project will be dropped from the application by DWR.
 - This may be waived for DACs.

1. DWR Application Process

DWR has presented a complete overhaul to the application process compared to previous grant solicitations. Rather than having each project sponsor create their own application, DWR has provided a standardized, fillable form for project sponsors to populate. Additionally, prior to submitting the final form, each project sponsor will present their project to DWR and other State agencies. These presentations will take place at the Funding Area level. So, over a one to two-day period, the 6 regions in our funding area will present our proposed projects to DWR for feedback regarding the project. Essentially, we will know with a level of confidence if the selected projects would be supported by DWR, prior to submitting the final application.

2. Funding Available for Round 1

The total funding available to our Region is summarized below, based on the Draft Grant PSP provided by DWR and the MOA between the Central Coast Funding Area IRWM regions. DWR anticipates awarding 50% of the available Implementation funds, as well as up to 35% of the DAC-specific Implementation funds. DWR's intention of holding back 65% of the DAC-specific funds for future rounds is for the planning work related to the Needs Assessments and DAC-Involvement Grant projects to be completed prior to awarding the majority of Implementation funds. Of course, the funds set aside for DAC Implementation is only a minimum.

3. RWMG Process for Selecting Projects

In general, the RWMG process for this opportunity will mirror what was used for the 2015 Prop 84 IRWM Implementation grant opportunity. This is a competitive process based on project merit and project sponsor's eligibility. Projects will be evaluated against DWR's provided scoring sheets to maximize potential for approval from DWR. The eligibility criteria provided in the Draft Project Solicitation Package is included as an attachment to this report.

DWR's scoring is both an evaluation of project merit and of application completeness. As with the 2015 grant selection process, not all scoring criteria that DWR is using will be used to generate our Region's list. Our selection process will focus only on the merit-based criteria and assumes a complete application will be provided. For example, our local selection process will not score a submitted project for #7 of DWR's scoring criteria "Does the Work Plan include a complete description of all tasks necessary to result in a completed project? Are all necessary and reasonable deliverables identified?". But, for example, projects will be evaluated for if they address contaminants listed in AB 1249 (Nitrate, Nitrite, chromium, etc.). The DWR project scoring sheet from the Draft PSP is attached, and the highlighted criteria are what local projects will be scored against.

Proposed schedule for SLO Region project selection:

- 1. 2/15 to 3/8, Project solicitation 3 weeks project sponsors will submit information to verify eligibility and project merit to DWR's scoring criteria.
- 2. 3/11 to 3/18, Project evaluation 1 week a staff-level team will review submitted materials and score projects.
- 3. 3/18 to 3/25, RWMG Working Group 1 week an RWMG Working Group will meet, possibly multiple times, to review the scoring and prepare a funding recommendation to the RWMG.
- 4. 4/3, Regular RWMG Meeting. The RWMG Working Group recommended projects and funding will be presented to the RWMG for consideration as the region's Prop 1, Round 1 IRWM Implementation Grant suite of projects.
- 5. 4/3, Regular WRAC Meeting. Assuming the RWMG approves a project and funding package for submittal, this will be presented to the WRAC for affirmation and support to an eventual Board of Supervisors vote.

With an expected timing of the funding area presentation to DWR being end of May or early June, this allows approximately 8 weeks for project proponents to:

- Provide all eligibility paperwork
- Complete the DWR Project Information Form
 - o Required to be submitted to DWR 2 weeks prior to the funding area presentation
- Prepare for the funding area presentation
 - Note, until told otherwise, this presentation is expected to be held outside of San Luis Obispo County (i.e. Moss Landing in Monterey County).

In the event a project needs to be removed or replaced from the application, we will have the flexibility to do so at the May 1st meeting, though it is not recommended given the time constraints for preparing for the funding area presentation and meeting DWR's timeline for prepresentation submittals.

Following funding area presentations, DWR will provide information as to whether they will support the project suite as-is or if they would like to see something else. Given this is a new

method for evaluating projects and providing input, the RWMG will need to remain flexible to respond to what kind of feedback DWR will provide.

Staff-Level Review Team

The 2015 Prop 84 Implementation grant process included County staff and a consultant team to evaluate and score projects. For this Prop 1 solicitation, a staff level review team will be assembled to score projects and verify eligibility. This team is intended to be staff members from the County as well as staff level members from other member agencies/organizations who are not submitting proposals for this grant funding round.

RWMG Working Group

An RWMG Working is recommended for consideration to review submitted project scores from the staff-level review team and prepare a funding recommendation for the RWMG to consider at an upcoming meeting. Participants of this Working Group will need to be available the week of March 18th. At a minimum, an RWMG Working Group is intended to include representation from each the North Coast, North County, and South County.
