Requirements

San Luis Obispo County's Land Use Ordinance (LUO; Title 22 of the County Code), at section 22.40.040 (O.), and Coastal Zone Land Use Ordinance (CZLUO; Title 23 of the County Code), at section 23.08.416 (q.), require all cannabis activities that receive a land use permit to participate in a County-run monitoring program (Program). The purpose of the Program is to verify that permitted activities are conducted in compliance with conditions of approval (including environmental mitigation measures), other approval documents (including the operations plan and security plan), and relevant provisions of the LUO, CZLUO and State law.

The County of San Luis Obispo Sheriff's Office has the primary responsibility to conduct local monitoring inspections. However, department staff may be assisted by other County departments, as well as representatives of State agencies. Please be advised that your project may be subject to additional inspection fees from outside agencies that will be billed separately.

In accordance with LUO section 22.40.110 and CZLUO section 23.08.430, any of the following shall be grounds for revocation of the land use permit, based on substantial evidence and following notice and a public hearing pursuant to LUO section 22.40.120 and CZLUO section 23.08.431:

- A. Failure to comply with one or more of the land use permit conditions.
- B. The land use permit was granted on the basis of false material information, written or oral, given willfully or negligently by the applicant.
- C. Any act or omission by an owner or permittee in contravention of the provisions of the LUO or CZLUO.
- D. Any act or omission by an owner or permittee that results in the denial or revocation of the owner's or permittee's State license.
- E. Any act or omission that results in the revocation of that owner's or permittee's commercial cannabis Business License Clearance under Title 6 of the San Luis Obispo County Code.
- F. Any act or omission by an owner or permittee in contravention of State law or the San Luis Obispo County Code on the site that received land use permit approval.
- G. An owner's or permittee's failure to take appropriate action to evict or otherwise remove persons conducting commercial cannabis activities who do not maintain the necessary permits or licenses in good standing with the County or State.
- H. Conviction for possession or delivery of any form of illegal drugs; or
- I. Conduct of the commercial cannabis activities in a manner that constitutes a nuisance, where the owner or permittee has failed to comply with reasonable conditions to abate the nuisance (e.g., odor).

Please note that failure to comply with the approval documents (including the Operations Plan and Security Plan) or this Cannabis Condition Monitoring Agreement may be grounds for revocation of your land use permit, in accordance with subsections A, C, or F of LUO section 22.40.110 and CZLUO section 23.08.430.

Department Fees

Cannabis Monitoring Program inspection fees are due upon invoicing. Sheriff's Office staff shall conduct quarterly inspections of the cannabis site to ensure compliance with all state and local requirements. To maintain land use approval, inspections of the cannabis site will be conducted year-round, whether or not cannabis is present on the site.

Current Cannabis Monitoring Program inspection fees are as follows. Please be advised that fees are subject to change per county fee schedule updates.

First Year Site Visits

Cultivation - \$11,570

Non-Cultivation - \$9,423

Annual License Renewal Background

Cultivation - \$18,702

Non-Cultivation - \$15,441

In addition, all cannabis permit holders are required to complete a San Luis Obispo County Sheriff's Office Cost Accounting Agreement. This agreement recognizes the department's authority to bill the property owner or operator pursuant to the department's fee schedule if additional department staff time is required for compliance monitoring and enforcement.
