5	Jet Fuel & Aviation Gasoline rates subject to change per market conditions, rates are minimum
6	Application fee is non-refundable and due with application submittal. Additional fees may apply for impacts, excess County staff hours, encroachment permits, FAA review, or extended term of permit on a case basis
7	Commercial Landing Fee: SBP may charge up to \$7.00/1000 lb Maximum Gross Landed Weight
8	Trip Charge Fee is minimum per trip each way and subject to change based on current market rates and/or as negotiated by agreement.
9	Restrictions apply. Camping is limited to pilots approved to fly into airport
10	General Aviation Landing Fee: SBP may charge up to \$5.00/1000 lb Maximum Gross Landed Weight,excludes SBP & L52 based aircraft and aircraft less than 6,000 MGLW published weight
