Dear Board of Supervisors;

Los Osos Community Advisory Council (LOCAC) is writing to you to request that you keep the North Coast Communities together when you finalize your redistricting project.

The North Coast has been consistently represented by a single Supervisor for over 50 years. The North Coast is a distinct community of interest as defined by the small towns along the North Coast, our common culture, environmental concerns, tourism, water concerns, and our dependence on highway 1.

The latest census data shows that the County of San Luis Obispo has only grown in population by a small amount. This small increase in population does not warrant any change to district boundary lines. The current districts as drawn meet all State criteria. LOCAC does not believe that any change to the district lines is needed. The new redistricting proposals will be in place for 10 years. LOCAC is asking the Board of Supervisors to please keep our coastal communities together so our voices can be heard.

Draft Map C removes both Cambria and San Simeon from the other coastal communities. This proposal will dramatically change the North Coast and further isolate the towns of Cambria and San Simeon. The only reason that the Board of Supervisors would change the redistricting lines would be purely political.

LOCAC asks the Board of Supervisors reject Map C and any other map that would divide the North Coast. State regulations state that redistricting requires communities of interest to stay intact. We are requesting the Board of Supervisors to keep our communities in the North Coast intact.

Message: I urge you to keep District 2 together as it presently exists. In your deliberations, the community of interest criteria is stated as a heavily weighted determination for the redistricting process. By splitting Cambria from district 2, the very opposite is achieved, e.g. Plan C. Cambria is primarily a small coastal community of retirees with tourist attractions and second homes for future retirees. Everything about Cambria from geological features, water and weather issues, traffic and land use differs from District 1. It is a unique coastal area, requiring a supervisor to devote enormous time to the special issues of coastal and forest concerns before the Coastal Commission and other organizations that support coastal and ocean issues. Even our representation before the federal government requires coastal knowledge and experience. We cannot allow this effort to wane by combining Cambria and San Simeon with another district with little coastal interest. Adding Cambria to another district completely different only dilutes the message and reduces its significance before legislative bodies. It has a quaint old town character with no large hotels, chain restaurants or 4 lane roads, and no industry except tourism. People often remark how quiet and peaceful it is and they come to get away from the hectic city life with its pollution and traffic. Presently, Cambria has serious challenges: providing water for the present population and whatever future growth is determined; forest rehab and preservation to protect from fire destruction; sea encroachment due to global warming; land use for preservation of the forest and coastal environment; upholding the county vacation rental ordinance regulations to maintain the residential character of its neighborhoods. The redistricting commission speaker stated at the 10/26 meeting that the county population had not changed considerably. So, why take such a radical step to dissect districts that have been together for decades and served the county well? Please take our community needs and concerns into consideration when deliberating our future and keep Cambria and San Simeon in District 2.

I note also that two scenarios place Cambria with either Paso Robles or Atascadero. I was born in Paso, and work in the area frequently on ranches, and smaller rural holdings. I was raised in Atascadero, and work in that area too. I have lived in Cambria for the past few years.

I urge you not to shift Cambria into a district with either Paso or Atascadero due to the notably few ranches here on the coast, and the myriad issues unique to Cambria given its location on the coast.
