**RESOLUTION NO. 24-23**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GROVER BEACH, CALIFORNIA, CALLING FOR THE HOLDING OF A GENERAL MUNICIPAL ELECTION TO BE HELD ON TUESDAY, NOVEMBER 5, 2024, FOR THE ELECTION OF CERTAIN OFFICERS AS REQUIRED BY THE PROVISIONS OF THE LAWS OF THE STATE OF CALIFORNIA RELATING TO GENERAL LAW CITIES**

**WHEREAS**, under the provisions of the laws relating to general law cities in the State of California, a General Municipal Election shall be held on Tuesday, November 5, 2024, for the election of Municipal Officers.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GROVER BEACH, CALIFORNIA, DOES DELARE, DETERMINE, AND ORDER AS FOLLOWS:**

SECTION 1. That pursuant to the requirements of the laws of the State of California relating to General Law Cities, there is called and ordered to be held in the City of Grover Beach, California, on Tuesday, November 5, 2025, a General Municipal Election for the purpose of electing a Mayor for the full term of two (2) years and two (2) Members of the City Council, one for District 3 and one for District 4, each for the full term of four (4) years.

SECTION 2. That the ballots to be used at the election shall be in form and content as required by law.

SECTION 3. That the City Clerk is authorized, instructed and directed to coordinate with the Office of the San Luis Obispo County Clerk-Recorder to procure and furnish any and all official ballots, notices, printed matter and all supplies, equipment, and paraphernalia that may be necessary in order to properly and lawfully conduct the election.

SECTION 4. That the polls for the election shall be open at seven o'clock a.m. of the day of the election and shall remain open continuously from that time until eight o'clock p.m. of the same day when the polls shall be closed, in accordance with Sections §10242, except as provided in §14401 of the Elections Code of the State of California.

SECTION 5. That in all particulars not recited in this resolution, the election shall be held and conducted as provided by law for holding municipal elections.

SECTION 6. That notice of the time and place of holding the election is given and the City Clerk is authorized, instructed, and directed to give further or additional notice of the election, in time, form and manner as required by law.

SECTION 7. That in the event of a tie vote (if any two or more persons receive an equal and the highest number of votes for an office) as certified by the San Luis Obispo County Clerk-Recorder, the City Council, in accordance with Election Code §15651(a), shall set a date and time and place and summon the candidates who have received the tie votes to appear and will determine the tie by lot.

SECTION 8. That the City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original Resolutions.

SECTION 9. The City Council authorizes the San Luis Obispo County Clerk-Recorder to administer said election and all reasonable and actual election expenses shall be paid by the City upon presentation of a properly submitted bill.

**RESOLUTION NO. 24-24**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GROVER BEACH, CALIFORNIA, REQUESTING THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN LUIS OBISPO TO CONSOLIDATE A GENERAL MUNICIPAL ELECTION TO BE HELD ON TUESDAY, NOVEMBER 5, 2024, WITH THE STATEWIDE GENERAL ELECTION TO BE HELD ON THE DATE PURSUANT TO §10403 OF THE ELECTIONS CODE**

**WHEREAS**, the City Council of the City of Grover Beach called a General Municipal Election to be held on Tuesday, November 5, 2024 for the purpose of electing a Mayor for the full term of two (2) years, and two (2) Members of the City Council for District 3 and District 4, each for the full term of four (4) years; and

**WHEREAS**, it is desirable that the General Municipal Election be consolidated with the Statewide General Election to be held on the same date and that within the city the precincts, polling places, and election officers of the two elections be the same, and that the County election department of the County of San Luis Obispo canvass the returns of the General Municipal Election and that the election be held in all respects as if there were only one election;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GROVER BEACH, CALIFORNIA, DOES DESOLVE, DECLARE, DETERMINE, AND ORDER AS FOLLOWS:**

SECTION 1. That pursuant to the requirements of §10403 of the Elections Code, the Board of Supervisors of the County of San Luis Obispo is hereby requested to consent and agree to the consolidation of a General Municipal Election with the Statewide General Election on Tuesday, November 5, 2024, for the purpose of electing a Mayor for the full term of two years, and two Members of the City Council, one for District 3 and one for District 4, each for the full term of four years; and

SECTION 2. That the San Luis Obispo County Clerk-Recorder Elections Division is authorized to canvass the returns of the General Municipal Election. The election shall be held in all respects as if there were only one election, and only one form of ballot shall be used. The election will be held and conducted in accordance with the provisions of law regulating the statewide election.

SECTION 3. That the Board of Supervisors is requested to issue instructions to the County Election Division to take any and all steps necessary for the holding of the consolidated election.

SECTION 4. That the City of Grover Beach recognizes that additional costs will be incurred by the County by reason of this consolidation and agrees to reimburse the County for election-related costs.

SECTION 5. That the City Clerk is hereby directed to file a certified copy of this resolution with the Board of Supervisors and the San Luis Obispo County Elections Division.

SECTION 6. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.

## RESOLUTION NO. 24-25

### **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GROVER BEACH, CALIFORNIA, ADOPTING REGULATIONS FOR CANDIDATES FOR ELECTIVE OFFICE PERTAINING TO CANDIDATES' STATEMENTS SUBMITTED TO THE VOTERS AT AN ELECTION TO BE HELD ON TUESDAY, NOVEMBER 5, 2024**

**WHEREAS**, §13307 of the Elections Code of the State of California provides that the governing body of any local agency adopt regulations pertaining to materials prepared by any candidate for a municipal election, including costs of the candidates statements.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GROVER BEACH, CALIFORNIA, DOES DELARE, DETERMINE, AND ORDER AS FOLLOWS:**

**SECTION 1. GENERAL PROVISIONS.** That pursuant to §13307 of the Elections Code of the State of California, each candidate for elective office to be voted for at an election to be held in the City of Grover Beach on Tuesday, November 5, 2024, may prepare a candidate's statement on an appropriate form provided by the City Clerk. The statement may include the name, age, and occupation of the candidate and a brief description of no more than 200 words of the candidate's education and qualifications expressed by the candidate himself or herself. The statement shall not include party affiliation of the candidate, nor membership or activity in partisan political organizations.

The statement shall be filed in typewritten form in the office of the City Clerk at the time the candidate's nomination papers are filed. In addition, the City Clerk shall request that candidates submit their statement in electronic format immediately before or after filing nomination papers, with the goal of improving efficiency in typesetting the statement and assuring fidelity in reproduction of the statement.

The statement may be withdrawn, but not changed, during the period for filing nomination papers and until 5:00 p.m. of the next working day after the close of the nomination period.

**SECTION 2. FOREIGN LANGUAGE POLICY.** Pursuant to the Federal Voting Rights Act, candidates' statements will be translated into all languages required, by the County of San Luis Obispo.

#### **SECTION 3. PAYMENT.**

**A. Translations:** The candidate shall be required to pay for the cost of translating the Candidate's Statement into any foreign language that is not required pursuant to federal and/or state law, but is requested as an option by the candidate.

#### **B. Printing:**

1. The candidate shall be required to pay for the cost of printing and/or electronically distributing the candidate's statement in English in the main voter pamphlet.

2. The candidate shall be required to pay for the cost of printing and/or electronically distributing the candidate's statement in a foreign language as requested by the candidate per Section 2 above in the main voter pamphlet.



3. The candidate shall be required to pay in advance to the City of Grover Beach his or her estimated pro rata share (as established in the current Master Fee Schedule) as a condition of having his or her statement included in the voter pamphlet. The estimate is just an approximation of the actual cost that varies from one election to another election and may be significantly more or less than the estimate, depending on the actual number of candidates filing statements. Accordingly, the City Clerk is not bound by the estimate and may, on a pro rata basis, bill the candidate for additional actual expense or refund any excess paid depending on the final actual cost. In the event of underpayment, the City Clerk may require the candidate to pay the balance of the cost incurred. In the event of overpayment, the City Clerk shall refund the excess amount paid within thirty (30) days of receipt of the final invoice from the County of San Luis Obispo.

SECTION 4. MISCELLANEOUS. The City Clerk shall comply with all recommendations and standards set forth by the California Secretary of State regarding occupational designations and other matters relating to elections.

SECTION 5. ADDITIONAL MATERIALS. No candidate will be permitted to include additional materials in the voter information guide.

SECTION 6. That the City Clerk shall provide each candidate or the candidate's representative a copy of this Resolution at the time nominating petitions are issued.


SECTION 7. That all previous resolutions establishing Council policy on payment for candidate statements are repealed.

**RESOLUTION NO. 24-26**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GROVER BEACH, CALIFORNIA, SUBMITTING TO THE VOTERS AT THE NEXT GENERAL MUNICIPAL ELECTION ON NOVEMBER 5, 2024, AN INITIATIVE MEASURE TO AMEND THE MASTER FEE SCHEDULE BY REPEALING THE WATER AND WASTEWATER RATES ADOPTED ON DECEMBER 11, 2023**

**WHEREAS**, the City Council of the City of Grover Beach has called a General Municipal Election to be held in the City of Grover Beach on Tuesday, November 5, 2024; and

**WHEREAS**, an initiative petition to amend the City's Master Fee Schedule and repeal Resolution 23-37 (hereinafter referred to as "Initiative Measure" or "Initiative Petition") has been submitted to the City in accordance with the requirements of the California Elections Code; and

**WHEREAS**, on May 13, 2024, the City Council accepted the Certificate of Sufficiency of the Initiative Petition issued by the City Clerk and directed staff to provide a report on the potential effects of the initiative; and

**WHEREAS**, on June 10, 2024, the City Council Accepted the report and voted to submit to the electors of the City of Grover Beach the Initiative Measure at the next general municipal election, scheduled on November 5, 2024.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GROVER BEACH, CALIFORNIA, DOES DECLARE, DETERMINE, AND ORDER AS FOLLOWS:**

**SECTION 1.** Initiative Measure Submitted to Voters at General Municipal Election. A regularly scheduled general municipal election has been called for the City of Grover Beach to be held on Tuesday, November 5, 2024. The following question is submitted to the voters at the election:

**SECTION 2.** Adoption of Measure. The full text of the measure to be submitted to the voters is as follows:

**INITIATIVE MEASURE TO BE SUBMITTED DIRECTLY TO THE VOTERS  
REPEALING RESOLUTION NO. 23-37 OF THE CITY COUNCIL OF THE CITY  
OF GROVER BEACH, CALIFORNIA, AMENDING THE MASTER FEE  
SCHEDULE FOR WATER AND WASTEWATER RATES**

**THE PEOPLE OF THE CITY OF GROVER BEACH DO ORDAIN AS FOLLOWS:**

**SECTION 1.** RESOLUTION NO. 23-37, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GROVER BEACH, CALIFORNIA, AMENDING THE MASTER FEE SCHEDULE FOR WATER AND WASTEWATER RATES", adopted December 11, 2023, IS HEREBY REPEALED in accordance with Section 3 of Article XIII C of the Constitution of the State of California.

**SECTION 2.** This measure may not be amended, except upon voter approval.

If a majority of qualified electors voting on such measure shall vote in favor of City of Grover Beach Initiative Measure "G-24", it shall be deemed ratified and shall read as provided above.

**SECTION 3. Notice of Election.** Notice of the time and place of holding the election is hereby given, and the City Clerk is authorized, instructed and directed to give further or additional notice of the election in time, form, and manner as required by law.

**SECTION 4. Impartial Analysis.** The City Council hereby directs the City Clerk to transmit a copy of the City Attorney's prepared impartial analysis of the measure, showing the effect of the measure on the existing law and the operation of the measure, and to provide such as required to the San Luis Obispo County Registrar of Voters.

**SECTION 5. Ballot Arguments.** Arguments in favor of or against the measure shall be submitted to the City Clerk on or before June 24, 2024, at 5:00 p.m. under Elections Code section 9286 et seq. If the City Clerk receives more than one argument for and/or against, the priorities established by Elections Code section 9287 shall control.

**SECTION 6. Rebuttal Arguments.** Rebuttal arguments shall be controlled by the provisions of Elections Code section 9285. The deadline for filing rebuttal arguments shall be July 1, 2024, at 5:00 p.m.

**SECTION 7. Duties of City Clerk.** The Grover Beach City Clerk shall do all things required by law to effectuate the November 5, 2024, general municipal election, including but not limited to causing the posting, publication and printing of all notices or other election materials under the requirements of the California Elections and Government Codes.


**SECTION 8. Non-substantive Changes.** The City Attorney is authorized to make any non-substantive changes and/or to correct minor administrative, procedural and clerical errors necessary to ensure the initiative measure is placed on the ballot for the November 5, 2024, general municipal election.

**SECTION 9. Transmittal of Resolution.** The City Clerk is hereby directed to submit a certified copy of this resolution to the Board of Supervisors and Registrar of Voters of the County of San Luis Obispo.
