Your **OFFICIAL VOTE-BY-MAIL BALLOT** is included with this Voter Information Guide and is accompanied by a postage-paid return envelope. This will be your only official mailing from the County.

THE VOTE-BY-MAIL PERIOD BEGINS NOW. As soon as you are ready, return your VBM ballot and **MAKE YOUR VOICE HEARD EARLY!**

Return your Vote-by-Mail ballot during the voting period of May 4th through **8:00 pm** on June 2nd.

You can return your ballot by:

 **Mail.** Be sure it is post-marked **on or before Election Day.** No postage necessary.

 **In person** at any **Elections Office, Vote Center, Polling Place, or Official VBM Ballot Drop Box** located in the State of California. The location of drop boxes in San Luis Obispo County can be found on the Vote-by-Mail instructions included with this mailing or at www.SloVote.gov.

Prefer to vote at your designated **polling location** between 7:00 am and 8:00 pm on Election Day?

To do that, please **bring your un-voted Vote-by-Mail ballot AND its return envelope** with you to surrender at your polling place.

The location of your polling place is listed at the top of your Vote-by-Mail ballot.

IMPORTANT TO KNOW BEFORE YOU VOTE

TOP TWO CANDIDATES

The Top Two Candidates Open Primary Act requires that all candidates for a voter-nominated office be listed on the same ballot. Voter-nominated offices include governor, state legislative offices, U.S. congressional offices, and state constitutional offices, among others.

In both the open primary and general elections, you can vote for any candidate regardless of what party preference you indicated on your voter registration form. In the primary election, the two candidates receiving the most votes—regardless of party preference—move on to the general election. If a candidate receives a majority of the vote (at least 50 percent + 1), a general election still must be held. California's open primary system does **not** apply to candidates running for local non-partisan offices.

In a direct primary, voters directly select their preferred candidate for a particular political party to run in the general election. This means

that each voter can vote for their chosen candidate, and the one with the most votes becomes the party's nominee.

Write-in candidates for voter-nominated offices can still run in the primary election. However, a write-in candidate can only move on to the general election if the candidate is one of the top two vote-getters in the primary election.

Your assigned polling location for this election may be different from what you were assigned in the past. Your current polling location is printed at the top of your Vote-by-Mail ballot.

SLO County polling locations will introduce **ePollbooks** in this primary election. The ePollbooks will replace the paper rosters and more info can be found at www.SloVote.gov/June2026.

ELECTIONS IN CALIFORNIA

VOTER-NOMINATED OFFICES

Political parties are not entitled to formally nominate candidates for voter-nominated offices at the primary election. A candidate nominated for a voter-nominated office at the primary election is the nominee of the people and not the official nominee of any party at the general election.

A candidate for nomination to a voter-nominated office shall have their qualified party preference, or lack of qualified party preference, stated on the ballot, but the party preference designation is selected solely by the candidate and is shown for the information of the voters only. It does not mean the candidate is nominated or endorsed by the party designated, or that there is an affiliation between the party and candidate, and no candidate nominated by the voters shall be deemed to be the officially nominated candidate of any political party.

The parties may submit a list of the candidates for voter-nominated offices who have received the party's official endorsement (see the Political Party Endorsements page).

NON-PARTISAN OFFICES

Political parties are not entitled to nominate candidates for non-partisan offices at the primary election, and a candidate at the primary election is not the official nominee of any party for the specific office at the general election.

A candidate for nomination to a non-partisan office may not designate their party preference, or lack of party preference, on the ballot. The top two vote-getters at the primary election move on to the general election for the non-partisan office.

Any candidate for a non-partisan office who receives a majority of the vote (at least 50 percent + 1) in the primary election will be elected to that office and the contest will not appear on the ballot for the general election.

Any voter may vote for any candidate for a voter-nominated office, if they meet the other qualifications required to vote for that office. The top two vote-getters at the primary election move on to the general election for the voter-nominated office, even if both candidates have specified the same party preference designation.

No party is entitled to have a candidate with its party preference designation move on to the general election unless the candidate is one of the two highest voter-getters at the primary election.

ELECTIONS IN CALIFORNIA

REQUIREMENTS FOR FIRST-TIME VOTERS

The Help America Vote Act (HAVA) requires first time federal voters to show identification when voting.

You will be required to show your current valid photo I.D. and/or a copy of one of the following that shows your name and address when you go to the polls on Election Day: current utility bill, bank statement, government check, government paycheck, or a government document.

You will be required to send a copy of one of the above documents with your voted Vote-by-Mail ballot. If you have questions about your status as a First Time Voter, please contact the Elections Office.

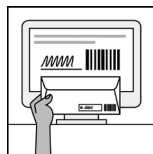
WHY YOUR BALLOT WOULD NOT BE COUNTED

Your voice is important. The Elections Office makes every effort to ensure that each vote cast is counted. That said, the following are reasons that a ballot would NOT be counted:

1. The ballot is not postmarked by June 2 and/or does not arrive within 7 days after Election Day.

2. The VBM return envelope is not signed.

3. The signature on the VBM return envelope does not match any signature in the voter's record.



4. The ballot is returned without the VBM return envelope.

5. There are multiple ballots in one VBM return envelope.

VBM CURE PROCESS

The law requires the Elections Office to send a letter and verification form to voters who forgot to sign their return envelope or whose signature did not match their signatures on file.

In order for these ballots to be counted, voters must sign and return their form prior to the deadline, which is two days before the election is certified.

WHY VOTE NOW?

Because VBM ballots received *before* Election Day are counted and included in the Election Night results

But don't worry: Every VBM ballot postmarked correctly and received within 7 days of the election will be counted

I was mailed a VBM ballot for a person who does not live at my address or is deceased. What's going on?

It likely means that voter registration records haven't yet been updated for that person. Ballots are mailed based on the most recent registration info on file, and the elections office relies on notifications from government agencies and voters themselves to keep voter rolls current. If the person does not live at your address or is deceased, you can mark the outside "Return to Sender – Not at this Address" to help with the update.

ELECTION SAFETY AND SECURITY

California's election systems are extremely safe and secure, and all 58 counties have a proven track record of conducting accessible and accurate elections. The California Secretary of State's Office makes this possible by overseeing one of the most extensive voting system testing and certification programs in the nation.

Unfortunately, misinformation about elections is widespread, and it continues to confuse voters and lead to distrust in the process.

The fact remains that the Elections Office in San Luis Obispo County carefully follows statewide elections code and takes many steps to ensure election security locally, including making the processing and counting of ballots publicly observable.

CALIFORNIA ELECTION SECURITY SAFEGUARDS

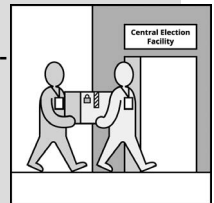
There are a number of steps that we take to ensure your vote is safe and secure throughout the election. Here are a few examples:

- County voting systems are not connected to the Internet, and all ballots are paper.
- Only authorized staff have access to systems relevant to their role.
- We conduct routine threat monitoring, vulnerability scanning, and security assessments in collaboration with our state and federal partners.

CHECK YOUR VOTER STATUS ONLINE

VoterStatus.sos.ca.gov

- VoteCal is a centralized statewide voter registration database. VoteCal checks against official records and is regularly updated.
- Ballot drop boxes are secured and monitored.
- Signatures are verified on all Vote-by-Mail envelopes.
- Ballots remain in dual (two-person) custody at all times.



HOW YOUR VOTE IS COUNTED

Polling places close at 8:00 pm on Election Night, but it can take a few hours for all locations to report results, and weeks before the final totals are known. Ever wondered why? Here's a quick look at what happens to your ballot after you cast it.

ELECTION NIGHT

The first results are posted shortly after 8:00 pm—these are the Vote-by-Mail ballots that were returned and processed early, prior to Election Day.

After that, we must wait for the first of the polling places across the county to complete their paperwork, pack up their supplies, and return the ballots; this can take more than an hour.

As polling places report in, their results are tabulated and compiled into countywide results. The posted results are updated periodically throughout the night at www.SloVote.gov.

When all polling places have reported, the Election Night counting is done; however, there are still more ballots to count and a lot more work to do before the results become official (see below).

BALLOTS COUNTED AFTER ELECTION DAY

Vote-by-Mail Ballots Received After the First Weekend in June: Vote-by-Mail ballots that arrive the

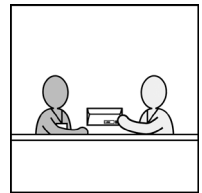
day before or on Election Day (either by mail, returned at a polling place, or deposited in an official ballot drop box) are processed and counted in the days after Election Day and therefore are **not** included in the Election Night results posted.

Postmarked Vote-by-Mail Ballots:

Under California law, ballots may be counted even if they arrive after Election Day, as long as they are received by mail no later than 7 days after the election and are postmarked on/before Election Day.

Missing or Mismatched Signature:

A voter's signature on the returned Vote-by-Mail identification envelope **must** compare with the signature(s) in the voter's registration record. If the voter did not sign the ballot envelope, or if the Elections Official has determined that the signature on the envelope does not match with the signature(s) of the voter in the voter's record, the Elections Office will provide the voter with the appropriate form to correct the missing or mismatched signature. This notice must be returned to the Elections Office no later than 2 days prior to the certification of the election.



Provisional

Ballots: These are the last ballots counted because they must be researched and verified. It may take a few weeks, but every valid vote will be counted.

WARNING: CORRUPTING THE VOTING PROCESS IS PROHIBITED

VIOLATIONS CAN LEAD TO FINES AND/OR IMPRISONMENT

IT IS PROHIBITED TO ENGAGE IN ANY OF THE FOLLOWING ACTIVITIES:

- DO NOT commit or attempt to commit election fraud.
- DO NOT bribe or provide any sort of compensation to, in any fashion, or by any means induce or attempt to induce, a person to vote or refrain from voting.
- DO NOT illegally vote.
- DO NOT attempt to vote or aid another to vote when not entitled to vote.
- DO NOT engage in electioneering; photograph or record a voter entering or exiting a polling place; or obstruct the entrance, exit, or parking.
- DO NOT challenge a person's right to vote or prevent voters from voting; delay the process of voting; or fraudulently advise any person that he or she is not eligible to vote or is not registered to vote.
- DO NOT attempt to ascertain how a voter voted their ballot.
- DO NOT possess or arrange for someone to possess a firearm in the immediate

vicinity of a polling place, with some exceptions per Elections Code 18544(b).

- DO NOT appear or arrange for someone to appear in the uniform of a peace officer, guard, or security personnel in the immediate vicinity of a polling place, with some exceptions per Elections Code 18544(b).
- DO NOT tamper or interfere with any component of a voting system.

The corruption of voting prohibitions summarized here are set forth in Articles 2, 3, and 4 of Chapter 6 of Division 18 of the California Elections Code.

- DO NOT forge, counterfeit, or tamper with the returns of an election.
- DO NOT alter the returns of an election.
- DO NOT tamper with, destroy, or alter any polling list, official ballot, or ballot container.
- DO NOT display any unofficial ballot collection container that may deceive a voter into believing it is an official collection box.

- DO NOT coerce or deceive a person who cannot read or an elder into voting for or against a candidate or measure contrary to their intent.
- DO NOT act as an election officer when you are not one.

EMPLOYERS cannot require or ask their employee to bring their Vote-by-Mail ballot to work or ask their employee to vote their ballot at work. At the time of payment of salary or wages, employers cannot enclose materials that attempt to influence the political opinions or actions of their employees.

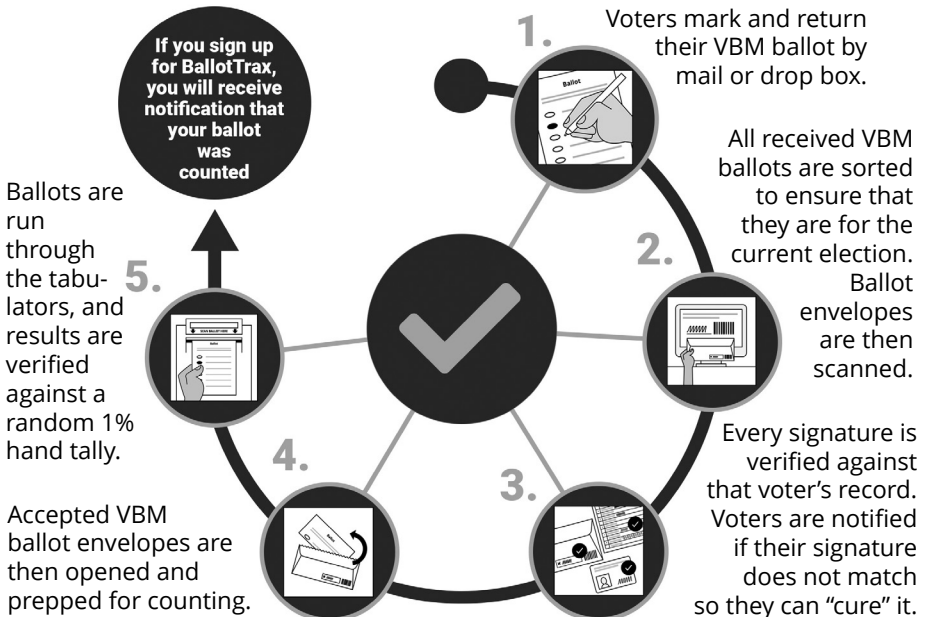
POLL WORKERS cannot attempt to determine how a voter voted their ballot or, if that information is discovered, disclose how a voter voted their ballot.

The prohibitions on activity related to corruption of the voting process summarized here are set forth in Chapter 6 of Division 18 of the California Elections Code.

ELECTIONEERING IS PROHIBITED

VIOLATIONS CAN LEAD TO FINES AND/OR IMPRISONMENT

WARNING: The following activities are prohibited within the immediate vicinity of a person in line to cast their ballot OR within 100 feet of the entrance to a polling place, curbside voting, or official ballot drop box.

- DO NOT ask a person to vote for or against any candidate or ballot measure.
- DO NOT display a candidate's name, image, or logo.
- DO NOT block access to or loiter near any ballot drop boxes.
- DO NOT provide any material or audible information for or against any candidate or ballot measure near any polling place or official ballot drop box.
- DO NOT circulate any petitions, including for initiatives, referenda, recall, or candidate nominations.
- DO NOT distribute, display, or wear any clothing (hats, shirts, signs, buttons, stickers) that includes a candidate's name, image and/or logo, or that supports or opposes any candidate or ballot measure.
- DO NOT display information or speak to a voter about the voter's eligibility to vote.

The electioneering prohibitions summarized here are set forth in Article 7 of Chapter 4 of Division 18 of the California Elections Code.

OBSERVING ELECTIONS

The public is invited to participate as a poll watcher or election observer. Both roles provide important insight into the process.

Rules for conduct are outlined in the California Elections Code, and more information can be found online at www.SloVote.gov.

Poll watchers observe operations at polling locations on Election Day, while election observers check in at the County Elections Office and are then able to observe various steps in the ballot processing and tabulation process. In both cases, there may be space limitations that impact how many can participate.

ASSISTANCE FOR VOTERS WITH DISABILITIES

San Luis Obispo County is committed to ensuring every voter can cast their ballot privately and independently. Below is detailed information about assistance offered to voters with disabilities.

Vote-by-Mail: Mark your ballot. Once completed, sign and seal your envelope. If you are unable to sign, make your mark and have a witness sign in the designated spot. Return your ballot by mail, or in person at any drop box, elections office, or polling site in California.

Vote at a Polling Place: On Election Day, you may choose up to two people to help you vote at any polling place or at the County Elections Office. This person cannot be your employer or anyone who works for your employer, your labor union leader, or anyone who works for your labor union.

- Accessible ballot-marking (ICX) machines are available at every polling place on Election Day and at the County Clerk-Recorder's Office beginning 29 days prior to the election. The ICX can mark a ballot in a number of ways and generate a paper ballot for tabulating.

- Curbside Voting: If you arrive at a polling place and cannot get to the voting area, call for assistance: **1-805-781-1888**

- Voter Information Guides are available on the County Clerk-Recorder's website for use with personal accessible navigational tools and screen reader technology.

- Large print format of the County Voter Information Guide and of the state ballot measure is available upon request.

REMOTE ACCESSIBLE VOTE-BY-MAIL (RAVBM)

The Elections Office offers voters the use of a Remote Accessible Vote-by-Mail system that allows a voter to mark their selections on a personal computer, using their own compatible technology or assistive device(s) (screen readers, tactile switches, closed captioning, sip and puff system, etc.) as needed, to vote independently and privately in the comfort of their own home.

VOTER BILL OF RIGHTS



You have the right to vote if you are a registered voter. You are eligible to vote if you are: a U.S. citizen living in California; at least 18 years old; registered where you currently live; not currently serving a state or federal prison term for the conviction of a felony; and not currently found mentally incompetent to vote by a court.



You have the right to vote if you are a registered voter, even if your name is not on the list. You will vote a provisional ballot. Your vote will be counted if elections officials determine that you are eligible to vote.



You have the right to vote if you are still in line when the polls close.



You have the right to cast a secret ballot without anyone bothering you or telling you how to vote.



You have the right to get a new ballot if, prior to casting your ballot, you believe you made a mistake. You can ask an election official at a polling place for a new ballot; exchange your Vote-by-Mail ballot for a new one at an elections office or at your polling place; or vote using a provisional ballot.



You have the right to get help casting your ballot from anyone you choose, except from your employer or union representative.



You have the right to drop off your completed Vote-by-Mail ballot at any polling place in California.



You have the right to get election materials in a language other than English if enough people in your voting precinct speak that language.



You have the right to ask questions to elections officials about election procedures and watch the election process. If the person you ask cannot answer your questions, they must send you to the right person for an answer. If you are disruptive, they can stop answering you.



You have the right to report any illegal or fraudulent election activity to an elections official or the Secretary of State's Office.

LOS OSOS COMMUNITY SERVICES DISTRICT IMPARTIAL ANALYSIS OF MEASURE B-26

This measure has been placed on the ballot through the initiative process by the submission of an initiative petition to the Board of Directors of the Los Osos Community Services District (“the District”), which was certified by the County Elections Official as having met the requisite number of voter signatures under Elections Code section 9310 to place the measure on the ballot. If more than half of the qualified voters vote to approve the measure, the ordinance will be enacted imposing a special tax on each parcel of real property located within the District.

The stated purpose of the measure is to generate revenue by the imposition of a special tax to fund the expansion, maintenance, and operations of local parks within the District, including the purchase and conversion of the Sunnyside School into a park and community resource.

The special tax is authorized by California Constitution, Article XIII A, Section 4 and Government Code section 61121. Because the measure has been proposed through the initiative process, the tax measure may be approved by a simple majority vote, rather than a super majority vote (2/3rds) otherwise required if the District’s Board of Directors (“the District Board”) had proposed the measure.

If approved, the special tax shall be levied annually by resolution of the District Board at the rate of \$185 per parcel. The measure provides that the tax proceeds shall be allocated and used as follows:

- The maximum rate of the parcel tax that may be used for the acquisition of Sunnyside School is \$85 per parcel annually, which will sunset after 15 years (by June 30, 2041) or earlier, as described in the measure.
- The remaining \$100 per parcel levied annually will be used to pay for park improvements, and operation and maintenance costs. This portion of the special tax will not sunset, and the District Board may adjust this amount annually, commencing July 1, 2027, by no more than the average of the percentage change in the Consumer Price Index (as described in the full text of the measure).

In accordance with California law, the District Board will be required to take certain accountability measures with regard to the tax proceeds, which include: (1) that proceeds generated by the special tax may be used only for the purposes identified in the measure; (2) creation of a separate account where the funds will be deposited; and (3) preparation of an annual report presented publicly, setting forth the amount of funds collected and expended, and the status of any project funded by the parcel tax proceeds.

On behalf of the District, the special tax will be collected by the San Luis Obispo County Tax Collector in the same manner, at the same time, and will be subject to the same penalties and delinquency procedures as other property taxes collected.

A “yes” vote on this measure is a vote in favor of imposing a special tax of \$185 per parcel annually for the purposes stated in the measure.

A “no” vote on this measure is a vote against imposing a special tax in the amount of \$185 per parcel annually for the purposes stated in the measure.

ARGUMENT AGAINST MEASURE B-26

The proposed Special Tax (B-26) is inadequate to accomplish anything but simply buying the former elementary school site and performing minimal maintenance. The tax provides no money for the expansion, improvement or adaptation for Parks & Recreation purposes. A Los Osos Community Services District (LOCSD) consultant estimated improvements would cost a minimum of \$5 million and up to \$10 million. In fact, deferred maintenance at Sunnyside makes it a potential liability.

The Sunnyside property is not conducive parks and recreation uses. There is over a fifty-foot elevation rise from Los Osos Valley Road to the rear of the site. Several plateaus on the property are mostly covered with old classrooms, portables and asphalt. Many of the expensive improvements promised will not be funded by the Special Tax. The measure touts the open space, which is important; however this is being accomplished with the \$40 million Los Osos Habitat Conservation Plan. Much of that money is intended for land acquisitions to complete formation of the "greenbelt" around Los Osos.

The LOCSD is ill-suited to own and manage such a significant undertaking. Currently, the LOCSD has no active Parks & Recreation function, almost no budget and no property management experience or staff. Moreover, the other higher priorities include increased fire department staffing and associated Special Fire Tax increase coming soon. Plus expensive groundwater basin management initiatives and related infrastructure projects.

The Sunnyside land lies in the "heart" of the Los Osos downtown, one that has struggled for decades. Given its strategic location, the site offers the potential for a civic or town center to establish a sense of place for the residents and an identity for Los Osos. A project that includes affordable and senior housing, artist's lofts and day care set around a large public plaza may serve thousands, not hundreds.

REBUTTAL TO THE ARGUMENT IN FAVOR OF MEASURE B-26

The proponents of the Special Property Tax Measure (B-26) have FAILED TO:

BE TRANSPARENT with voters about the bad condition of Old Sunnyside; including black mold, asbestos, Lead-based paint and rodent infestations not to mention the limited prospects for any future improvements.

ACKNOWLEDGE higher priorities facing Los Osos and the millions needed for water infrastructure projects and fire protection.

PURSUE the purchase of flat land like the less expensive, 7-acre site across South Bay Blvd. from the Middle School, if sincere about parks and recreation.

RECOGNIZE the existing tax burden on residents including the \$165 million of sewer debt for most Los Osos properties and the absence of additional taxation "bandwidth".

APPRECIATE the availability of existing parks, trails and open spaces in and around Los Osos. Montana de Oro to the 200-plus acre Morro Dunes Ecological Reserve above Highland Dr. to the Elfin Forest, all offer great recreational opportunities.

CONDUCT a true community outreach, and instead crafted a tax amount less than the perceived "pain" threshold, however not enough to actually fund the promised creation of a new community park with sports fields.

SUPPORT a long-held community goal of realizing a town center with public plaza and a mix of residential and commercial uses that would serve thousands, not hundreds.

BE CANDID about who is behind this new special tax, and admit the LOCSD was the impetus and is using the "citizen's group" simply to reduce the approval threshold from 66% to 50%.

No on B-26 because of the FAILURES!

REBUTTAL TO THE ARGUMENT AGAINST MEASURE B-26

The argument against B-26 rests on several flawed premises and omissions.

First, B-26 is intentionally designed to acquire Sunnyside and fund operations and maintenance, creating the platform to pursue grants, philanthropy, and partnerships for phased improvements. Calling the tax “inadequate” because it doesn’t fund the entire build-out on day one misrepresents how park projects are typically financed.

Second, labeling Sunnyside’s topography and buildings a “liability” ignores modern park design and adaptive reuse. Multi-level sites and existing structures are routinely transformed into valuable public assets—playfields, community centers, performance spaces, and childcare—when communities invest over time.

Third, invoking the Habitat Conservation Plan as a substitute for local parks confuses regional habitat protection with neighborhood recreation. The greenbelt preserves habitat and community edges; B-26 gives kids, families, and seniors a place to gather, play, and connect in town.

Fourth, it is incorrect to say the LOCS D is “ill-suited” to own and manage Sunnyside. The district already has a Parks and Recreation function, and Sunnyside would expand that role. The parcel tax will provide stable funding to support additional staff and professional management. Acquiring Sunnyside lets LOCS D grow its parks capacity while addressing a severe shortage of usable community park space in Los Osos.

Finally, the supposed “choice” between Sunnyside and a hypothetical civic center with housing is false. Nothing in B-26 blocks downtown revitalization or new housing elsewhere. B-26 simply secures the last, best central site for public use before it is permanently lost.

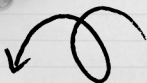

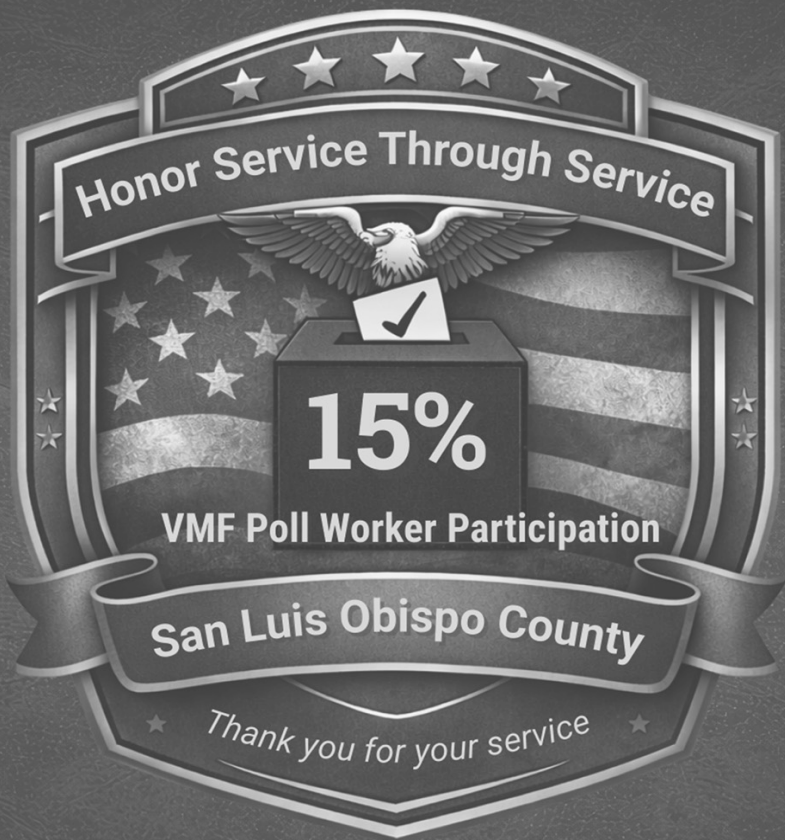

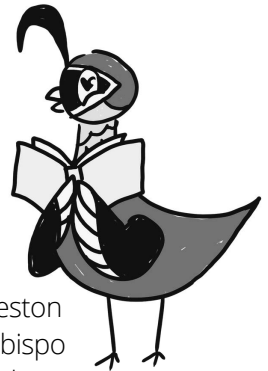

WHY LICENSE YOUR DOG?

805-781-4400

- 🐾 Your dog's license is his ticket home if he is ever picked up running at large. Animal Control Officers would rather reunite you with your pet than impound him. If he's wearing a current license, they'll bring him home instead of to the shelter.
- 🐾 License revenues help support Animal Services efforts to address the needs of homeless and neglected pets and to resolve our community's animal-related problems.
- 🐾 It's the law.

HELPFUL INFO

- 🐾 The metal tag your vet gives you when your pet is vaccinated is not a license tag.
- 🐾 State law requires all dogs to have a current rabies vaccination before they can be licensed. If your dog doesn't have vaccination information on file with Animal Services, you will need to submit it with your application.
- 🐾 License fees are significantly discounted if your dog has been spayed or neutered.
- 🐾 By law, the duration of your dog's license validity cannot exceed the expiration date of his current rabies vaccine.
