<b>June 5 - 14, 2020</b> EC Sec 9380	<b>PUBLIC EXAMINATION PERIOD</b> – Ten-day examination period begins the day after the adoption of the resolution by the Governing Board.
<b>June 19, 2020</b> EC Sec 9316	<b>BY THIS DATE</b> the Elections Official shall send the Notice Calling for Submission of arguments FOR or AGAINST the measure to be published.
<b>July 17, 2020</b> EC Sec 9161-9163, 9315-9316, 9501-9503, 9600-9601	<b>PRIMARY ARGUMENTS DUE</b>  <b>LAST DAY</b> for proponent(s) to change or withdraw Primary Arguments.
<b>July 17, 2020</b> EC Sec 9160, 9313, 9401, 9500	<b>IMPARTIAL ANALYSIS DUE</b> from County Counsel. <b>TAX RATE STATEMENT WAS SUBMITTED</b> (Bond Measures only)
<b>July 18 - 27, 2020</b> EC Sec 9190, 9380, 9509	<b>PUBLIC EXAMINATION PERIOD</b> - Primary Arguments, Analysis and/or Tax Rate Statement & Fiscal Impact Statement.
<b>July 28, 2020</b> EC Sec 9167, 9317, 9504, 9600-9601	<b>REBUTTAL ARGUMENTS DUE</b> - File with the County Elections Official. <b>LAST DAY</b> for proponent(s) to change or withdraw Rebuttal Arguments.
<b>July 29 -Aug 7, 2020</b>	<b>PUBLIC EXAMINATION PERIOD</b> - For Rebuttals Only.
<b>August 7, 2020</b>	<b>LAST DAY</b> for Governing Boards to submit their resolutions requesting consolidation of their election with the November 3, 2020, General Election.
<b>September 24, 2020</b> (E-40)	<b>SAMPLE BALLOT BOOKLETS MAILED</b>
<b>October 5, 2020</b> (E-29)	<b>MAILING OF VOTE BY MAIL BALLOTS BEGINS</b>

\* denotes a date that falls on a county holiday or weekend. Deadline extends until the next business day.

(E+) or (E-) = Election Day plus or minus the number of days.
