If the question is the Full Text of the Measure, this needs to be stated in the resolution. File the original resolution with the County Elections Official</p>

<p>Nov 19 – December 2, 2019</p>	<p>PUBLIC EXAMINATION PERIOD - For Rebuttals Only.</p>
<p>January 23, 2020 (E-40)</p>	<p>SAMPLE BALLOT BOOKLETS MAILED TO POLL VOTERS</p>
<p>February 3, 2020 (E-29) EC §3001</p>	<p>MAILING OF VOTE BY MAIL BALLOTS BEGINS</p>
