Thank you for licensing your dog with Animal Services. Licensing your dog has many benefits to you, your pet, and the San Luis Obispo community. Licensing fees help San Luis Obispo's Animal Services provide food and shelter for lost, unwanted, injured, abandoned, and mistreated animals, while also supporting our efforts to assist the community with animal related safety and nuisance concerns and complaints. Maintaining a current license also helps us to reunite you with your pet if they become lost or run away from home, and if your dog's license is current and all of your contact information is up to date, the first impound fee will be waived.

A current rabies vaccination is required for the issuance or renewal of a license. Regardless of the type of license purchased (1 or 3 year), the duration of a license cannot extend beyond the expiration of the vaccine.

The only requirement to license your dog is that they are current with their rabies vaccination. A license is only as good as long as the rabies vaccine is current. The day that the rabies vaccine expires is also the license expiration date, even if it is before the end of the 12 or 36 month licensing period your dog is in.

1 YEAR UNALTERED	\$80	1 year license for a dog this is not spayed or neutered.
1 YEAR UNALTERED SENIOR RATE	\$67	1 year license for a dog this is not spayed or neutered with owners over 65.
1 YEAR SPAY/NEUTERED	\$32	1 year license for any altered dog.
1 YEAR SPAY/NEUTER SENIOR RATE	\$28	1 year license for any altered dog at a discounted rate for citizens over the age of 65.
3 YEAR SPAY/NEUTERED	\$79	If your dog receives a 3 year rabies vaccine then you can also purchase a 3 year license at a discounted rate.
3 YEAR SPAY/NEUTERED SENIOR RATE	\$67	This is the same license as above, but at a discounted rate for citizens over the age of 65.
3 YEAR UNALTERED	\$193	If your dog receives a 3 year rabies vaccine then you can also purchase a 3 year license at a discounted rate.
3 YEAR UNALTERED SENIOR RATE	\$167	This is the same license as above, but at a discounted rate for citizens over the age of 65.
LATE FEE	\$25	If you are more than 30 days past due on your initial licensing or renewal a late fee will be accessed.
TAG REPLACEMENT	\$7	If your TAG/ID is lost you will be issued a new Tag and Tag/ID # for a minimal fee.

## Licensing Terms and Fees:

Licensing is required for all dogs over the age of 4 months that live within or will reside in San Luis Obispo County limits for more than 30 days per year (cumulative). Owners have 30 days after moving to the area, obtaining a new dog, or receiving the first rabies vaccination (puppies) to license their dog(s) without incurring a late fee. Proof of a current Rabies vaccination is required at the time of new licensing or licensing renewal.

## Temporary Licenses

If you are missing any information to complete the licensing process at the time of issuance, you will be issued a temporary license for a specified amount of time (most often 30 days). To ensure your license is fully instated and no additional fees are assessed, please submit all necessary documents by the expiration date specified on the front side of this form.
