How Much Will It Cost To Process My Residential Construction Permit?

The fees for construction permits are set by the county fee ordinance each year. They are based on the cost of processing your application. Fees vary depending on the size and type of construction proposed. This brochure will give you a general estimate of costs for typical residential permits that do not need special planning, coastal, flood hazard, or other reviews.  - grading on slopes greater than 10%, and/or
 - more than 5,000 cubic yards.
- (4) NPDES fees for disturbance > 1 acreadd \$1,076 for < 5000 cubic yds or add \$1,681 for > 5,000 cubic yds.
- (5) Retaining Wall fee add \$504 per Engineered retaining wall add \$393 per Non-Engineered retaining wall.
