Washer Rebate Program Application

Terms and Conditions

The Washer Rebate Program offers monetary incentives for property owners who remove old water inefficient washers and replace them with approved Energy Star certified washers. Rebates are available to qualifying property owners on a first-come, first-served basis while funding is available. Funding availability is subject to change at any time.

Applicability:

- Property must overlie and use water from the Nipomo Mesa Water Conservation Area or the Paso Robles Groundwater Basin.
- The old washer must be currently installed at the time of application. Washers installed prior to January 1, 2017 are ineligible for a rebate.
- A minimum of **15 gallons** of water per day must be saved to qualify for a rebate. A rebate amount of \$250 may be issued based on completion and compliance of the program requirements.

Application:

- Program applicants must submit a complete application to waterprograms@co.slo.ca.us or 976 Osos St., Room 300 San Luis Obispo, CA 93408. The application must include specific information regarding the old and new washers which must conform to the following requirements:

Washer Rebate Requirements:

- Property must overlie and use water from the Nipomo Mesa Water Conservation Area or the Paso Robles Groundwater Basin.
- Limit of one (1) rebate per household.
- The application must be complete and include all applicable water information:
 - Gallons used per cycle
 - Volume of the tub in cubic feet
- The new washer must be Energy Star certified and with an integrated water factor (IWF) of 3.2 or lower.

Washer Rebate Program Application

- The County of San Luis Obispo will not honor rebates for used or reconditioned washers, or washers purchased prior to January 1, 2017.
- A copy of the receipt and a “before and after” photograph of the old and newly installed washer shall be sent to the County of San Luis Obispo Planning and Building Department before a rebate may be issued.
- The new washer must save at a minimum 15 gallons or more per day to be eligible for the rebate.

Process:

- County staff will review the application for completeness and compliance with program requirements.
- County staff will confirm eligibility.
- Applicant will purchase a new, water efficient Energy Star certified washer with an integrated water factor (IWF) of 3.2 or lower.
- Applicant has 2 months, or 60 days, to purchase and install new washer in accordance with applicable County building codes.
- A copy of the purchase receipt and “before and after” photographs of the old and newly installed washer (included Make/Model/Serial Number) shall be sent to the Department of Planning and Building.
- County staff will verify the total water savings and authorize the rebate which the applicant should receive in the mail within 4-5 weeks from the date of confirmation

Terms and Conditions

I agree that by virtue of program inspections, the County of San Luis Obispo makes no determination with respect to whether materials and equipment are free of defects, the quality of the workmanship, the suitability of the premises or the materials or equipment for the installation. I also understand that the installation of a new washer may not result in lower water costs. I agree to defend, indemnify and hold harmless the County of San Luis Obispo, its directors, officers, agents and employees against any and all loss, liability, expense, claims, suits and damages, including attorney's fees, arising out of or resulting from the installation of the new washer or from participation in this program.
