1. Welcome and Introductions

Committee Members, staff, and guests introduce themselves.

2. Announcements

3. Review and Approval of Past Meeting Minutes: Tuesday, March 19, 2024

County staff ask for questions or comments from the Committee; there are none.

Motion to approve: Linda Austin Seconded by: Gary Kobara

Approval: Motion passes by unanimous vote

4. Ongoing Updates

a) Storm Response Efforts

County staff provide verbal updates on recent storm response efforts.

Charlie Lackie: How will repairs be made to the areas where rocks are falling out and into the creek?

County staff: We anticipate installing additional rock slope protection on the internal slope of the south levee. The rock will be keyed into the base.

Charlie Lackie: Have the environmental agencies voiced concern over the design changes to the levee?

County staff: We are coordinating with the permitting agencies and working on a path forward. They are aware of the work that needs to be done.

Charlie Lackie: Have you done modeling since you've changed the course of the levee? If not, when will this be done.

County staff: We have cross sections for some areas. The model will be updated once the projects have been completed.

Charlie Lackie notes that there will be a potential water source for aquadam deployment on his property and would like to coordinate with staff.

Tim Crawford: Is there any repair work planned for the erosion of the inner wall near Rancho del Arroyo and the East Gate?

County Staff: That work is not in the scope of the current contract, but we can take a look at it.

Charlie Lackie: Is there a contract out for the railroad repair.

County staff: A contract was awarded, but the work is contingent upon approval from Union Pacific.

Charles Varni: It appears that the bridge support monuments that were reinforced by Union Pacific are deflecting flow into the wall of the levee; has this been analyzed at any point?

County staff: We can check with our consultant to see if that has been incorporated into the model.

b) Annual Workplan Efforts

County staff provide verbal updates on Annual Workplan efforts.

Greg Cobb: Are the Sand Canyon flap gates supposed to be cleared annually?

County staff: The goal is to perform clearance annually, but Sand Canyon presents an issue due to environmental constraints and regulations. We'll need to wait for the area to dry out before we can clear vegetation.

Dianna Lackie: Is KD Janni the contractor for the vegetation clearance in the channel? We haven't seen them in our section yet.

County staff: They are making their way back from the delta triangle towards your section.

Tim Crawford: Will they be removing downed trees/branches in the secondary channel.

County staff: Yes, we are currently working to identify what can be removed.

c) Emergency Response Plan

County staff provide verbal updates on emergency response planning efforts.

No comments.

d) Other Flood Protection Planning Efforts

County staff provide verbal updates on other flood protection planning efforts.

5. Emergency Watershed Protection Program - Property Buyout Option

County staff provide verbal updates on the Emergency Watershed Protection Program.

Karen White: Will the property structures be removed?

County staff: Yes, the property structures will be removed or demolished.

6. Meadow Creek Lagoon Update and Presentation

County staff provide a status update and presentation on the Meadow Creek Lagoon Habitat Restoration Project.

Jeremy Ghent comments on the design of the flap gates and clarifies the conditions in which they operate.

Greg Cobb: How could Alternative 3 be an option over Alternative 4? Isn't restoration of Meadow Creek Lagoon a requirement? Have you gone back and looked at what it used to look like? Who approves the final recommendations?

County staff: It is less about focusing on a specific area (MCL or AG Creek), and more about satisfying the intent of the RPA and to improve and increase steelhead habitat. National Marine Fisheries Service is one of the agencies that will be approving the project.

Charles Varni: How does this project impact flood protection for the Sanitation District? And do any alternatives reduce the risk of flooding?

County staff: None of the alternatives will increase the potential for flooding. It is not the intention of the project to reduce flood risk.

Linda Austin: With Alternative 3 and the Sand Canyon Flap gate, will there be sediment removal and dredging?

County staff: Alternative 3 will explore excavation or dredging of the lagoon area to deepen the water for steelhead.

Greg Cobb: Will the public have opportunities to provide input on the recommendations?

County staff: Yes, the findings of the preferred alternative will be presented to the Zone 1/1A Advisory Committee, a report will be produced and released to the public for comments during the CEQA review period, and responses to the comments will be published.

Charles Varni: What is the approximate pool depth required for steelhead?

County staff: 4 feet of depth.

Dianna Lackie: Is this project going to impact the levee?

County staff: We are actively avoiding any alternatives that may alter the levee or exacerbate conditions.

Committee members and staff discuss the history of the levee system, past maintenance activities, modern environmental restrictions, and other impacts to the levee.

7. Public Comment

Charlie Lackie: Can you provide an updated Zone 1/1A staff contact list?

County Staff: Yes, we will provide a contact list for Committee Members.

Greg Cobb: It's been nearly two years; any efforts to expedite repairs to the levee would be greatly appreciated.

Jeremy Ghent: Levee patrols are welcome to park their vehicle at the Sanitation District lot during storm events.

a) Storm Response Efforts

Arroyo Grande Creek Channel Emergency Levee Rehabilitation Phase 2 Project
Odin Environmental Services has recently completed Phase 2B of the AG Creek Channel Emergency
Levee Rehabilitation Project. The scope of this project was construction of four hydraulic barrier walls
down the centerline of damaged sections of the levee to protect from future seepage and erosional
damages. Staff continues to coordinate with FEMA regarding reimbursement for temporary and
permanent repair work, including emergency repairs completed in January 2023, Phase 1 and Phase
2A and 2B.

Staff also continues coordinating with Union Pacific Railroad (UPRR) to acquire the necessary right-of-way agreements for the AG Creek Channel Additive TRM and Breach Site Stabilization Project. This project includes (1) installation of turf reinforcement mat (TRM) adjacent to existing TRM on the external slope of the south levee; and (2) installation of additional rock slope protection on the internal slope of the south levee.

b) Annual Workplan and Maintenance Efforts

The Annual Work Plan was submitted to the regulatory agencies in April and the District is completing its typical channel maintenance activities, including channel cross sections, hydraulic modeling, and vegetation maintenance. Pending results from the current modeling analysis, a sedimentation removal effort is anticipated Spring/Summer 2025. Staff have also completed property maintenance activities, including clearing flap gates, vegetation maintenance, goat grazing, homeless encampment removal and addressing any issues that may impact the integrity of the flood control system.

c) Emergency Response Plan

Last season's storms are being used as an opportunity to refine the hydrologic computer model and other predictive tools for flood monitoring. A more comprehensive update of the Emergency Response Plan will be prepared as needed after model updates and construction of the projects.

d) Other Flood Protection Planning Efforts

In March 2024, federal funds were appropriated under the Pre-Disaster Mitigation (PDM) Congressionally Directed Spending grant program to support the District's AG Creek Channel flood protection efforts. This prompted District Staff to submit an application in coordination with the California Office of Emergency Services (CalOES) to fund a project scoping activity that will evaluate

feasible flood mitigating solutions for increasing flood protection of properties surrounding the AG Creek Channel. It is anticipated that FEMA will complete their review and obligate funds in 2025.

Staff is continuing to coordinate with members of the Arroyo Grande Creek and Watershed Memorandum of Understanding (MOU) agreement on the Watershed Plan update project. The next meeting is scheduled for December 18th and the agenda can be found here. The meeting will feature a tour of the recently completed fish passage improvement project at the Arroyo Grande stream gage site.

e) Meadow Creek Lagoon

The District is continuing the review of the Draft Alternatives Report prepared by Stillwater Consulting which details project requirements for restoring habitat in Meadow Creek Lagoon (Alternative 3) or Arroyo Grande Creek Lagoon (Alternative 4). The Science Panel met on September 13th and received input and feedback from the Panel on the two alternatives. Another meeting is planned for Monday, December 9th to get further direction from the Panel prior to moving forward with an alternative. An update on the outcome from the science panel meeting will be presented during the advisory committee meeting on December 10th, 2024.

f) Emergency Watershed Protection Program - Property Buyout Option

The District has signed an agreement with the Natural Resources Conservation Service (NRCS) to voluntarily purchase a property located on the south side of the Arroyo Grande Creek and ultimately remove all structures to restore the floodplain to its natural functioning condition. Staff is currently working with engineering consultants on draft demolitions plans. Demolition is expected in Summer 2025 once the appropriate permits are acquired.
