## Trends in Senior Care for 2024 A Geriatric Care Manager's View

Presenter: Alexandra Morris Certified Geriatric Care Manager

#### Intro

- Only 3 active geriatric care managers taking new cases in San Luis Obispo county
- 2 of these are specialized in dementia
- At this moment these 3 care managers are not taking cases whose primary issue is mental illness such as bipolar, schizophrenia, personality disorder etc...
- One of the geriatric care manager is an RN, Paul

#### **Statistics**

- Currently about 17% of the population in the United Sates is 65+ older
- This percentage is quickly shifting to a much larger percentage
- Less young and middle age population and much larger percentage of 65 + older
- Japan has the largest 65+ older population, almost 30%
- Currently 22% of the population in San Luis Obispo county is 65+ older

#### Who are we? What do we do?

- 30 years ago certified geriatric care was not a known career
- Currently society/community is still puzzled at what exactly this career is or does including health care professionals
- Nursing homes back then were the only service available to help
- Most come into the profession from other disciplines such as, SWs, nurses, other health professionals
- Younger population have started to show an interest
- Most have a master's degree
- To be a member of the national organization you will need to:
  - Have another credential
  - > Do the work for at least 2 years, full time, paid and supervised
  - > Testing process
- Strict code of ethics and standards of practice process
- Hourly fees between \$100-\$200/hour
- Very limited long term care insurance policies pay for this care
- Medicare does not pay for this care

## **Working with Fiduciaries**

- When there is no one to make decisions on behalf of the senior and no family members involved, fiduciaries are brought in
- When existing trusties are unable to do what they are supposed to
- When the caregiver becomes incapacitated or dies and no one else is available

### How is the help offered?

- Create a care plan with a professionally written report
- Links to services offered
- Sometimes crisis intervention
- Evaluate
- Talk to family
- Share responsibilities with families and determine time frames
- Connecting people to primary care physicians
  - Capacity declarations
  - Medical prescriptions, refills
- Embrace technology
- Blue Zones (5)
  - ➤ A blue zone is a region in the world where people are claimed to have exceptionally long lives beyond the age of 80 due to a lifestyle combining physical activity, low stress, rich social interactions, a local whole-foods diet, and low disease incidence
