The District Attorney of the San Luis Obispo County, California, by this information accuses the above named defendant of the following criminal offenses:

Count 1

On or about May 5, 2018, in the County of San Luis Obispo, State of California, the crime of Willful, Deliberate, And Premeditated Murder in violation of Penal Code Section 187(a), a Felony, was committed in that CARLO ALBERTO FUENTESFLORES did unlawfully and with malice aforethought murder N.W., a human being.

It is further alleged as to Count 1 that the murder was committed while the defendant was engaged in the commission of, or attempting to commit, the crime of rape in violation of

1 Penal Code Section 261 within the meaning of Penal Code Section 190.2(a)(17)(C).

3 It is further alleged as to Count 1 that the murder was committed while the defendant was
4 engaged in the commission of, or attempting to commit, the crime of residential burglary in
5 violation of Penal Code Section 460, within the meaning of Penal Code Section
6 190.2(a)(17)(G).

8 It is further alleged that the aforesaid murder was committed willfully, deliberately and with
9 premeditation within the meaning of Penal Code Section 189, and is a serious felony
10 pursuant to Penal Code Section 1192.7(c), and a violent felony within the meaning of
11 Penal Code Section 667.5(c)(1).
