COMPLAINTS AGAINST DISTRICT ATTORNEY INVESTIGATORS:

YOU HAVE THE RIGHT TO MAKE A COMPLAINT AGAINST A DISTRICT ATTORNEY INVESTIGATOR FOR ANY IMPROPER CONDUCT. CALIFORNIA LAW REQUIRES THIS AGENCY TO HAVE A PROCEDURE TO INVESTIGATE CITIZENS' COMPLAINTS AGAINST INVESTIGATORS, AND A WRITTEN DESCRIPTION OF THIS PROCEDURE IS AVAILABLE UPON REQUEST. THIS AGENCY MAY FIND AFTER INVESTIGATION THAT THERE IS NOT ENOUGH EVIDENCE TO WARRANT ACTION ON YOUR COMPLAINT; EVEN IF THAT IS THE CASE, YOU HAVE THE RIGHT TO MAKE THE COMPLAINT AND HAVE IT INVESTIGATED IF YOU BELIEVE AN INVESTIGATOR BEHAVED IMPROPERLY. CITIZEN COMPLAINTS AND ANY REPORTS OR FINDINGS RELATING TO COMPLAINTS MUST BE RETAINED BY THIS AGENCY FOR AT LEAST FIVE YEARS.

IT IS AGAINST THE LAW TO MAKE A COMPLAINT AGAINST AN INVESTIGATOR THAT YOU KNOW TO BE FALSE. IF YOU MAKE A COMPLAINT AGAINST A DISTRICT ATTORNEY INVESTIGATOR KNOWING THAT IT IS FALSE, YOU CAN BE PROSECUTED ON A MISDEMEANOR CHARGE (California Penal Code section 148.6(a)(1)).
