21 The District Attorney of the San Luis Obispo County, California, by this information  
22 accuses the above named defendant of the following criminal offenses:

23 Count 1

24 On or about March 2, 2019, in the County of San Luis Obispo, State of California, the  
25 crime of Murder in violation of PC187(a), a Felony, was committed in that DANIEL RAUL  
26 RODRIGUEZ JOHNSON did unlawfully and with malice aforethought murder C.B., a  
27 human being.

Enhancement

PC12022(b)(1): Spec Alleg-Use Of Deadly Weapon

It is further alleged as to count 1 that in the commission and attempted commission of the above offense, the said defendant, DANIEL RAUL RODRIGUEZ JOHNSON, personally used a deadly and dangerous weapon, to wit, a knife, said use not being an element of the above offense, within the meaning of Penal Code Section 12022(b)(1) and causing the above offense to be a serious felony within the meaning of Penal Code section 1192.7(c)(23).

Count 2

On or about March 2, 2019, in the County of San Luis Obispo, State of California, the crime of Murder in violation of Penal Code Section 187(a), a Felony, was committed in that DANIEL RAUL RODRIGUEZ JOHNSON did unlawfully, and with malice aforethought murder a human fetus.

NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c) and a violent felony within the meaning of Penal Code Section 667.5(c)

*Allegation of Special Circumstance (PC 190.2)*

It is further alleged as to count 1 and 2 that the Defendant in this proceeding committed more than one offense of murder in the first or second degree within the meaning of Penal Code Section 190.2(a)(3).

Count 3

On or about March 3, 2019, in the County of San Luis Obispo, State of California, the crime of Carjacking in violation of PC215(a), a Felony, was committed in that DANIEL RAUL RODRIGUEZ JOHNSON did unlawfully take a motor vehicle in the possession of Officer M. Egan from his person and immediate presence, against the will and with the intent to permanently and temporarily deprive the person in possession of the motor vehicle of the possession and accomplished by means of force and fear.

NOTICE: The above offense is a violent felony within the meaning of Penal Code 667.5(c).

1 NOTICE: The above offense is a serious felony within the meaning of Penal Code Section  
2 1192.7(c).

3 Count 4

4 On or about March 3, 2019, in the County of San Luis Obispo, State of California, the  
5 crime of Evading a Peace Officer in violation of California Vehicle Code Section 2800.2(a),  
6 a Felony, was committed in that DANIEL RAUL RODRIGUEZ JOHNSON did willfully and  
7 unlawfully, while operating a motor vehicle and with the intent to evade, flee and otherwise  
8 attempt to elude a pursuing peace officer's motor vehicle while all of the following  
9 conditions existed: the peace officer's motor vehicle exhibited at least one lighted red lamp  
10 visible from the front and the defendant saw and reasonably should have seen the lamp,  
11 the peace officer's motor vehicle was sounding its siren as was reasonably necessary, the  
12 peace officer's motor vehicle was distinctively marked, the peace officer's motor vehicle  
13 was operated by a peace officer. It is further alleged that the defendant drove with a willful  
14 wanton disregard for the safety of persons and property.

15 Count 5

16 On or about March 3, 2019, in the County of San Luis Obispo, State of California, the  
17 crime of Unlawful Driving Or Taking Of A Special Vehicle in violation of VC10851(b), a  
18 Felony, was committed in that DANIEL RAUL RODRIGUEZ JOHNSON did unlawfully  
19 drive and take a certain vehicle, to wit, California Highway Patrol Vehicle, then and there  
20 the personal property of California Highway Patrol without the consent of and with intent,  
21 either permanently or temporarily, to deprive the said owner of title to and possession of  
22 said vehicle, in violation of subdivision (b), subsection (2) a distinctively marked vehicle of  
23 a law enforcement agency.

24 Count 6

25 On or about March 3, 2019, in the County of San Luis Obispo, State of California, the  
26 crime of Resisting Executive Officer in violation of PC69, a Felony, was committed in that  
27 DANIEL RAUL RODRIGUEZ JOHNSON did unlawfully attempt by means of threats and  
28 violence to deter and prevent California Highway Patrol Officer Egan, who was then and

1 there an executive officer, from performing a duty imposed upon such officer by law, and  
2 did knowingly resist by the use of force and violence said executive officer in the  
3 performance of his duty.

4 Count 7

5 On or about March 3, 2019, in the County of San Luis Obispo, State of California, the  
6 crime of Exhibiting A Deadly Weapon in violation of PC417(a)(1), a Misdemeanor, was  
7 committed in that DANIEL RAUL RODRIGUEZ JOHNSON did unlawfully, in the presence  
8 of another, draw and exhibit a deadly weapon in a rude, angry and threatening manner  
9 and did use a deadly weapon in a fight and quarrel.
