The District Attorney of the San Luis Obispo County, California, by this information
accuses the above named defendant of the following criminal offenses:

Count 1

On or about August 13, 2018, in the County of San Luis Obispo, State of California, the
crime of Corporal Injury To Spouse/Cohabitant/Child's Parent in violation of PC273.5(a), a
Felony, was committed in that TYRELL PAUL HEBERT did willfully and unlawfully inflict
corporal injury resulting in a traumatic condition upon Confidential Victim, who was the
mother of defendant/minor's child.

Count 2

On or about August 13, 2018, in the County of San Luis Obispo, State of California, the crime of Cruelty To Child By Inflicting Injury in violation of PC273a(b), a Misdemeanor, was committed in that TYRELL PAUL HEBERT did, under circumstances and conditions other than those likely to produce great bodily harm and death, willfully and unlawfully inflict on Confidential Victim, a child of eleven years, unjustifiable physical pain and mental suffering and injure, cause, and permit said child to suffer.

Count 3

On or about August 14, 2018, in the County of San Luis Obispo, State of California, the crime of Attempted Criminal Threats in violation of PC664/PC422(a), a Felony, was committed in that TYRELL PAUL HEBERT did willfully and unlawfully threaten to commit a crime which would result in death and great bodily injury to Confidential Victim, with the specific intent that the statement be taken as a threat. It is further alleged that the threatened crime, on its face and under the circumstances in which it was made, was so unequivocal, unconditional, immediate and specific as to convey to Confidential Victim a gravity of purpose and an immediate prospect of execution. It is further alleged that the said Confidential Victim could have been reasonably in sustained fear of his/her safety and the safety of his/her immediate family.

NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c).

The People hereby give notice of the People's intent to admit evidence of prior acts of domestic violence pursuant to Evidence Code section 1109. These incidents include the prior incident(s) described in the police report, chronological report, and/or tapes already provided, and other alleged incidents of abuse, which will be provided as they are obtained by the prosecution.

1 The People hereby notify defendant and defense counsel that the People intend to
2 proceed under the provisions of Evidence Code section 1370 should the victim become
3 unavailable at the time of trial.
