Greetings:

I was shocked to learn that the clearly gerrymandered Patten map was adopted by the Board of Supervisors. It has no advantages for county residents and has many disastrous disadvantages. For instance: --The new districts have been devised to give Republicans—who are a minority by population in the county—almost perpetual rule. --A perfect illustration of the fancy footwork required to attain that Republican advantage is the skinny dog-bone-shaped version of District 3, which connects SLO to Morro Bay via a long, mostly empty span of highway. --San Miguel is separated from Paso Robles—its closest neighbor and strongest community of interest. --The whole point of the Patten map was—patently—to keep cities whole. Yes SLO is still divided. So, clearly, that was not the real point at all. --As the nonpartisan League of Women Voters has pointed out, the Patten map also accelerates some 48,000 Republican voters and defers 48,000 Democrats. Again, this is no coincidence but is part of the Republican power grab. --State law states that communities of interest should be kept together. But not only is San Miguel split from Paso Robles but Los Osos and Morro Bay—about as close, in terms of interests, as two towns can get—are separated. --And not only that, but Cayucos and Morro Bay are also split. Ignoring the fact that residents of Cayucos are in Morro Bay constantly for shopping, that their children attend school there. --Splitting up Los Osos and Morro Bay is literal insanity; the two towns have so much in common that “local” to a resident of either one can mean either town. --And grouping Los Osos with Avila Beach is also ludicrous--it takes forty minutes even to get from one to the other. You might as well group Los Osos with San Miguel, for all the use this would do. (But hold on: that’s already happened for Cambria.) The map the board selected is clearly intended to engineer and cement minority rule for the next ten years. That is not democracy. Is it not absurd to give the power to redraw the map to the very people who will benefit from the new boundaries? This should have been entrusted to a nonpartisan panel. The Patten map spits in the face of the democratic ideals that are America. It is clearly a power grab by a group of politicians who are afraid they won't prevail in an election free of gerrymandered districts. This will be appropriately challenged in court and end up costing the County of San Luis Obispo taxpayers a bundle as the supervisors try to defend the indefensible.

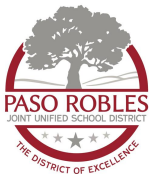

Dear SLO County Board of Supervisors,

I find it highly concerning that the conservative majority ended up voting for the Patten map at the 11/30 hearing, after a majority of public comment was in support of other more fair and balanced maps - Map A for the 11/19 hearing and the SLO Chamber of Commerce Map for the 11/30 hearing.

To vote against having Redistricting Partners crunch data on the registered party makeup of each of the proposed districting maps by saying that it is not allowed is a disingenuous misinterpretation of the law. Your very own SLO County Counsel, Rita Neal, has confirmed that you are allowed to possess partisan information about the redistricting maps in order to make an informed decision?

What you are doing, but what you are not allowed to do is adopting, "supervisorial district boundaries for the purpose of favoring or discriminating against a political party," as stated in Election Code (section 21500(d)). The party affiliation of residents in each district is [publicly accessible data](#). As of August 2021, there are 7,000 more registered Democrats than Republicans. And yet, you have chosen the Patten map that would carve out the districts to highly favor Republican candidates in 3 of the 5 districts.

You have chosen the Patten map knowing that it would disenfranchise thousands of voters like myself and move the majority of residents into different districts. As Redistricting Partners has shared with you at the 11/30 hearing, with the Patten Map, the 48,622 accelerated voters are primarily in areas that have voted Republican historically, while the 49,418 deferred voters are in more Democratic leaning areas.

You may feign ignorance, but you know and I know you selected the gerrymandered Patten Map to favor your own political party.

To vote against having Redistricting Partners crunch data on the registered party makeup of each of the proposed districting maps by saying that it is not allowed is a disingenuous misinterpretation of the law. Your very own SLO County Counsel, Rita Neal, has confirmed that you are allowed to possess partisan information about the redistricting maps in order to make an informed decision?

As a Latina living in District 4, I am deeply concerned that the proposed redistricting will divide the Latino vote and make it impossible for us to successfully elect county representatives who share our experiences and care about what matters to us

By separating Oceano from Nipomo you are crippling the Latino vote on the central coast. According to the 2020 Census, both Nipomo and Oceano are approximately 45% Hispanic. In comparison, Arroyo Grande is only 14.2% Hispanic, Grover Beach is 31.5% Hispanic, and just 16.1% of people in Los Osos identify as Hispanic. Breaking up Nipomo and Oceano will dilute our vote and create huge barriers to the fair representation we deserve.

The Final map selected by the Board violates Section 21503 (c) and (d) of the elections code and the Board should not adopt the ordinance under consideration to redraw the supervisorial district lines.

Section 21500 (c) lays out in priority order criteria for establishing/adopting supervisorial district boundaries. The geographic integrity of a local community of interest shall be respected to minimize its division. This criteria was not adhered to in the final map approved by the Board's majority. Los Osos and Morro Bay is a well established community of interest with many common economic, social and public policy concerns in common. Oceano and Nipomo are a long time community of interest sharing ag and public policy concerns such as the Oceano/Nipomo Dunes and repurposing of the Phillips 66 property. Santa Margarita and Atascadero is another well established community of interest being divided in the Patten map. These are just a few examples that substantial public commenters have already addressed, requesting the Board to keep these communities in one district. It makes no sense to separate these communities.

Section 21500 (d) states: "The board shall not adopt supervisorial district boundaries for the purpose of favoring or discriminating against a political party." This provision of the law is meant to prevent gerrymandering, yet that is exactly what this is. Data read into the record clearly shows that the Patten map adopted by your Board favors one political party (Republicans) and discriminates against another (Democrats). This despite current voter registration data that shows Republicans are in the minority in this county. The map packs Democrats into one "sink" district (D3) and to a lesser extent, into D5. The maps "cracks" Democrats in other districts to dilute their vote (D2 and D4). This is in clear violation of Section 21500 (d).

It is very hard to believe that this is not being done for political purposes, to lock in Republican control of the Board for the next ten years. It is hard to believe that political data was not considered when choosing the final map, even subliminally. The Board members are politicians and know the political landscape of this county and where their base is located. At a minimum, they know this for their own district. The Final map selected by the Board violates Section 21503 (c) and (d) of the elections code and the Board should not adopt the ordinance under consideration to redraw the supervisorial district lines.

Section 21500 (c) lays out in priority order criteria for establishing/adopting supervisorial district boundaries. The geographic integrity of a local community of interest shall be respected to minimize its division. This criteria was not adhered to in the final map approved by the Board's majority. Los Osos and Morro Bay is a well established community of interest with many common economic, social and public policy concerns in common. Oceano and Nipomo are a long time community of interest sharing ag and public policy concerns such as the Oceano/Nipomo Dunes and repurposing of the Phillips 66 property. Santa Margarita and Atascadero is another well established community of interest being

divided in the Patten map. These are just a few examples that substantial public commenters have already addressed, requesting the Board to keep these communities in one district. It makes no sense to separate these communities.

Section 21500 (d) states: "The board shall not adopt supervisorial district boundaries for the purpose of favoring or discriminating against a political party." This provision of the law is meant to prevent gerrymandering, yet that is exactly what this is. Data read into the record clearly shows that the Patten map adopted by your Board favors one political party (Republicans) and discriminates against another (Democrats). This despite current voter registration data that shows Republicans are in the minority in this county. The map packs Democrats into one "sink" district (D3) and to a lesser extent, into D5. The maps "cracks" Democrats in other districts to dilute their vote (D2 and D4). This is in clear violation of Section 21500 (d).

It is very hard to believe that this is not being done for political purposes, to lock in Republican control of the Board for the next ten years. It is hard to believe that political data was not considered when choosing the final map, even subliminally. The Board members are politicians and know the political landscape of this county and where their base is located. At a minimum, they know this for their own district. The data that has been read into the record clearly explains why the Republican party rallied around the Patten map and used it in their workshops to generate support amongst its base.

Please vote to adopt into law, map 74786. Attempts to threaten a lawsuit by dissenters should not be a deterrent to doing the right thing. The lie being broadcast is that we can go back to using the old map or the 2030 map, however, neither follows the new criteria given by the state.

**Please note:** Santa Barbara County who decided to go with a Citizens Independent Redistricting Commission voted 11- 0 to adopt a map that keeps Isle Vista and the University of Santa Barbara together with Goleta and Santa Barbara.
