# State Homekey Program

**CDBG-CV2:** County to apply on behalf of HASLO for \$5.1 million in CDBG-CV2 (CARES Act) funds to rehabilitate transitional housing and emergency shelter facility

**HOMEKEY Program:** Create by state for agencies to acquire hotels, motels, apartments to provide homes for people experiencing or are at-risk of homelessness



# CARES Act CDBG-CV2 Funds

**What's Available?:** \$50 million for Homekey Projects throughout the state – first come, first served

**Criteria:** Prevent, prepare for, and respond to the coronavirus

Housing is the best method to prevent the spread of the coronavirus

# HASLO's Homekey Project

**What's the proposal?:** Interior and exterior rehabilitation and of the grounds, including, but not limited to: roof repair; temporary relocation; plumbing upgrades; electrical upgrades; permanent housing kitchen upgrades; bathroom remodels; food preparation area, security cameras; fire sprinkler and water filtration system; furniture; painting; irrigation; addition of a stairway; project soft costs; administration by the County . . . and more.



# 5-Day Comment Period and Workshop

**August 4 Virtual Workshop:** Provide the public with an opportunity to comment on the proposed project and application by the County for state CARES Act CDBG-CV2 funds.

**5-Day Comment Period:** August 2 through August 9, 2021 to provide comments to the County.
