Count 11

On or about July 21, 2020, in the County of San Luis Obispo, State of California, the crime of False Imprisonment (Misdemeanor) in violation of PC236, a Misdemeanor, was committed in that TIANNA ISIS ARATAWENTWORTH did unlawfully violate the personal liberty of John Doe driver of Black Toyota sedan on Monterey Street west of Santa Rosa Street, San Luis Obispo, California.

Count 12

On or about July 21, 2020, in the County of San Luis Obispo, State of California, the crime of Disturbing The Peace By Loud Noise in violation of PC415(2), a Misdemeanor, was committed in that TIANNA ISIS ARATAWENTWORTH did willfully, unlawfully, and maliciously disturb another person by loud and unreasonable noise in violation of subsection (2), on Monterey Street between Chorro Street and Morro Street, San Luis Obispo, California.

Count 13

On or about July 21, 2020, in the County of San Luis Obispo, State of California, the crime of False Imprisonment (Misdemeanor) in violation of PC236, a Misdemeanor, was committed in that TIANNA ISIS ARATAWENTWORTH did unlawfully violate the personal liberty of John Doe driver of dark Honda Pilot at intersection of Pacific Street and Chorro Street, San Luis Obispo, California.

1 All of which is contrary to the statute in such cases made and provided, and against
2 the peace and dignity of the People of the State of California.

3 I declare that an investigation has been conducted to determine if said Defendant(s)
4 did commit the stated crime, which reports are attached hereto and incorporated herein by
5 reference, and that the facts therein show probable cause that the said Defendant(s) did
6 commit the crime. Your declarant requests the issuance of a Warrant of Arrest either if
7 said Defendant(s) do not appear voluntarily in response to an appearance letter, or if no
8 appearance letter was issued.

9 **Discovery Request:** Pursuant to Penal Code Section 1054.5(b), the People are
10 hereby informally requesting that defense counsel provide discovery to the people as
11 required by Penal Code Section 1054.3.
