2 pain and mental suffering, and, having the care and custody of said child, injure, cause,
3 and permit the person and health of said child to be injured and did willfully cause and
4 permit said child to be placed in such situation that his/her person and health was/were
5 endangered.

6 Count 2

7 On or about July 10, 2019, in the County of San Luis Obispo, State of California, the crime
8 of Child Abuse in violation of PC273a(a), a Felony, was committed in that CHEYNE ERIC
9 ORNDOFF AND VANESSA MARIE BEDRONI did willfully and unlawfully, under
10 circumstances likely to produce great bodily harm and death, injure, cause, and permit a
11 child, Juliette Doe (DOB 8-17-11), to suffer and to be inflicted with unjustifiable physical

18 of Possession Of A Controlled Substance in violation of HS11377(a), a Misdemeanor, was
19 committed in that CHEYNE ERIC ORNDOFF AND VANESSA MARIE BEDRONI did
20 unlawfully possess a controlled substance, to wit, Methamphetamine.
