19 The District Attorney of the San Luis Obispo County, California, by this information  
20 accuses the above named defendant of the following criminal offenses:

21 Count 1-

22 On or about February 11, 2020, in the County of San Luis Obispo, State of California, the  
23 crime of Evading An Officer, Willful Disregard in violation of VC2800.2(a), a Felony, was  
24 committed in that LARIO GARCIA TUGAS did willfully and unlawfully, while operating a  
25 motor vehicle and with the intent to evade, flee and otherwise attempt to elude a pursuing  
26 peace officer's motor vehicle while all of the following conditions existed: the peace  
27 officer's motor vehicle exhibited at least one lighted red lamp visible from the front and the  
28 defendant saw and reasonably should have seen the lamp, the peace officer's motor

1 vehicle was sounding its siren as was reasonably necessary, the peace officer's motor  
2 vehicle was distinctively marked, the peace officer's motor vehicle was operated by a  
3 peace officer. It is further alleged that the defendant drove with a willful wanton disregard  
4 for the safety of persons and property.

5 Count 2

6 On or about July 12, 2021, in the County of San Luis Obispo, State of California, the crime  
7 of Resisting Executive Officer in violation of PC69, a Felony, was committed in that LARIO  
8 GARCIA TUGAS did unlawfully attempt by means of threats and violence to deter and  
9 prevent Officer J. WALSH, who was then and there an executive officer, from performing a  
10 duty imposed upon such officer by law, and did knowingly resist by the use of force and  
11 violence said executive officer in the performance of his/her duty.

12 Count 3

13 On or about July 12, 2021, in the County of San Luis Obispo, State of California, the crime  
14 of Unlawful Driving or Taking of a Vehicle in violation of VC10851(a), a Felony, was  
15 committed in that LARIO GARCIA TUGAS did unlawfully drive and take a certain vehicle,  
16 to wit, 2018 KAWASAKI Z125 MOTORCYCLE, then and there the personal property of  
17 B.M. without the consent of and with intent, either permanently or temporarily, to deprive  
18 the said owner of title to and possession of said vehicle.

19 Enhancement

20 It is further alleged as to Counts 2 and 3 that at the time of the commission of the above  
21 offense, the defendant, LARIO GARCIA TUGAS, was released from custody on bail or  
22 Own Recognizance on Count 1 (VC2800.2(a)) in Case Number 20F-01446 within the  
23 meaning of Penal Code section 12022.1.

24 Count 4

25 On or about February 11, 2020, in the County of San Luis Obispo, State of California, the  
26 crime of Driving When Privilege Suspended Or Revoked in violation of VC14601.1(a), a  
27 Misdemeanor, was committed in that LARIO GARCIA TUGAS did unlawfully drive a motor  
28 vehicle upon a highway at a time when his/her driving privilege was suspended and

1 revoked for a reason other than one listed in Section 14601 and 14601.2 of the Vehicle  
2 Code, to wit, Failure to Appear, and when he had knowledge of such suspension and  
3 revocation.

4  
5 Contrary to the form, force and effect of that statute in such cases made and  
6 provided and against the peace and dignity of the people of the State of California.
