On or between October 24, 2018 and October 25, 2018, in the County of San Luis Obispo,
23 State of California, the crime of Willful, Deliberate, And Premeditated Murder in violation of
24 PC187(a), a Felony, was committed in that LEVENTE LASZLO LAZAR did unlawfully and
25 with malice aforethought murder Athena Ilona Valentiny, a human being. It is further
26 alleged that the aforesaid murder was committed willfully, deliberately and with
27 premeditation within the meaning of Penal Code section 189 and is a serious felony

PC12022(b)(1): Spec Alleg-Use Of Deadly Weapon

It is further alleged as to count 1 that in the commission and attempted commission of the above offense, the said defendant, LEVENTE LASZLO LAZAR, personally used a deadly and dangerous weapon, to wit, a sharp object, said use not being an element of the above offense, within the meaning of Penal Code Section 12022(b)(1) and causing the above offense to be a serious felony within the meaning of Penal Code section 1192.7(c)(23).

Enhancement

PC190.2(a)(1): Spec Alleg-Murder For Financial Gain

It is further alleged as to count 1 that the murder of Athena Ilona Valentiny was intentional and was carried out by the defendant, LEVENTE LASZLO LAZAR for financial gain, within the meaning of Penal Code Section 190.2(a)(1).
