The District Attorney of the San Luis Obispo County, California, hereby accuses the above named defendant of the following criminal offenses:

Count 1
On or about July 13, 2018, in the County of San Luis Obispo, State of California, the crime of Assault To Commit A Felony During The Commission Of A First Degree Burglary in violation of PC220(b), a Felony, was committed in that ARTHUR TIOFILO ROCHA did during the commission of a first degree burglary assault $\square$, with the intent to commit rape, sodomy, oral copulation and a violation of sections 264.1, 288, and 289. NOTICE: Conviction of this offense will require you to register pursuant to Penal Code section 290. Willful failure to register is a crime.

NOTICE: The above offense is a violent felony within the meaning of Penal Code 667.5(c). It is further alleged that the threatened crime, on its face and under the circumstances in which it was made, was so unequivocal, unconditional, immediate and specific as to convey to a gravity of purpose and an immediate prospect of execution. It is further alleged that the said $\square$ was reasonably in sustained fear of his/her safety and the safety of his/her immediate family. NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c)

It is further alleged that the threatened crime, on its face and under the circumstances in which it was made, was so unequivocal, unconditional, immediate and specific as to convey to a gravity of purpose and an immediate prospect of execution. It is further alleged that the said $\square$ was reasonably in sustained fear of his/her safety and the safety of his/her immediate family.
