On or about February 1, 2020, in the County of San Luis Obispo, State of California, the crime of Pimping in violation of PC266H(a), a Felony, was committed in that GUY ALVIN AZAMA JR did unlawfully, and knowing T.M.E. to be a prostitute, live and derive support and maintenance in whole and in part from the earnings and proceeds of said person's prostitution and from money loaned and advanced to and charged against said prostitute by a keeper, manager, and inmate of a house and other place where prostitution was practiced and allowed and did solicit and receive compensation for soliciting said prostitute.

NOTICE: Penal Code 1203.065(a) prohibits a grant of probation for this offense.

1 All of which is contrary to the statute in such cases made and provided, and against
2 the peace and dignity of the People of the State of California.

3 I declare that an investigation has been conducted to determine if said Defendant(s)
4 did commit the stated crime, which reports are attached hereto and incorporated herein by
5 reference, and that the facts therein show probable cause that the said Defendant(s) did
6 commit the crime. Your declarant requests the issuance of a Warrant of Arrest either if
